

Government Schemes

I. Social Security & Welfare Schemes

Expanded Social Security Coverage: India's social protection coverage has notably increased, doubling from 24.4% in 2021 to 48.8% in 2024, according to the International Labour Organization's (ILO) World Social Protection Report 2024-26. This expansion is attributed to key initiatives like:

- Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (AB-PMJAY): This scheme provides free health coverage of up to ₹5 lakh per family. As of March 2025, over 39.94 crore Ayushman Cards have been issued.
- Pradhan Mantri Garib Kalyan Anna Yojana (PMGKAY): Providing free food grains to vulnerable populations, this scheme had reached 80.67 crore beneficiaries as of December 2024.
- eShram Portal: Launched in 2021 to create a National Database of Unorganised Workers (NDUW), it has registered over 30.68 crore unorganised workers as of March 2025, with over half being women.
- Atal Pension Yojana (APY): Aimed at providing universal social security, particularly for the unorganised sector, it had 7.25 crore beneficiaries by December 2024.
- Pradhan Mantri Jeevan Jyoti Bima Yojana (PMJJBY) and Pradhan Mantri Suraksha Bima Yojana (PMSBY): These schemes offer low-cost life accident insurance respectively, with significant enrollments.
- Pradhan Mantri Shram Yogi Maandhan Yojana (PM-SYM): Ensures a pension of ₹3,000 per month to unorganised workers after 60.

PM Vishwakarma: Launched on September 17, 2024, this scheme supports traditional artisans and craftspeople with collateral-free loans, toolkit incentives, and marketing help. As of June 9, 2025, 23.7 lakh artisans have registered.

PM Awas Yojana (PMAY) Urban 2.0: This initiative addresses housing needs for 1 crore urban middle-class and poor families with a significant investment and plans to build 3 crore more houses in rural and urban areas.

Healthcare Coverage for Frontline Workers: The Union Budget 2024-25 extends healthcare coverage under Ayushman Bharat PMJAY to Anganwadi workers, ASHA workers, and community healthcare helpers, providing financial assistance up to ₹5 lakh per family annually.

NPS Vatsalya: A new scheme for contributions by parents/guardians for minors, convertible to a normal NPS account upon majority.

PM SHRI Scheme: Aims to transform existing government schools into model schools, focusing on components of the National Education Policy 2020, "Green schools" initiatives, and modern facilities.

II. Infrastructure & Development Projects

PM's Visit to Bihar and West Bengal (July 18, 2024): Prime Minister Narendra Modi is set to inaugurate and lay foundation stones for multiple development projects worth over ₹7,200 crore in Motihari, Bihar, and over ₹5,000 crore in Durgapur, West Bengal. These projects span various sectors:

- ➤ Rail: Automatic signalling, doubling of rail lines (Darbhanga-Thalwara, Samastipur-Rambhadrapur, Darbhanga-Narkatiaganj), Vande Bharat train maintenance infrastructure at Patliputra. Four new Amrit Bharat trains will also be flagged off.
- ➤ Road: 4-laning of Ara bypass of NH-319, inauguration of 4-lane Parariya to Mohania section of NH-319, and a 2-lane with paved shoulder from Sarwan to Chakai of NH-333C.





- Electronics & IT: Inauguration of new Software Technology Parks of India (STPI) facility at Darbhanga and a state-of-the-art Incubation Facility of STPI at Patna to boost IT/ITES/ESDM industry and startups.
- Fisheries: Launch modern of infrastructure under Pradhan Mantri Matsya Sampada Yojana (PMMSY), including new fish hatcheries, biofloc units, and ornamental fish farming across Bihar.

NHAI's Highway and Expressway Projects (2025-26):

The National Highways Authority of India (NHAI) plans to bid out 124 highway and expressway projects worth ₹3.4 lakh crore in the current financial year (2025-26). Approximately 78% of these projects will be under Public-Private Partnership (PPP) mode, including major stretches like Gorakhpur-Kishangan-Siliguri and Patna-Purnea. This comes after a slowdown in project awards over the past two years, partly due to the requirement of 90% land availability before bidding.

Rooftop Solarisation Scheme (PM Surva Ghar Muft Bijli Yojana): Announced in the Budget 2024-25, this scheme aims to provide 300 units of free electricity per month to 1 crore households through rooftop solarisation, offering annual savings and promoting entrepreneurship.

Atmanirbharta for Oil Seeds Abhiyan: A strategy to achieve self-sufficiency in oilseeds through modern farming techniques, research for high-yielding varieties, value addition, procurement, market linkages, and crop insurance.

PM Gati Shakti Master Plan: Launched in 2021, this plan continues to be a dedicated digital platform integrating multiple ministries and departments to facilitate seamless coordination and reduce delays in infrastructure development projects across India.

SDG India Index 2023-24: Released in July 2024 by NITI Aayog, this index continues to monitor India's progress towards Sustainable Development Goals (SDGs) at national and sub-national levels, fostering competition and knowledge sharing among states and UTs.

III. Other Notable Initiatives/Updates

South Asia Child Immunisation Coverage: A new report by UNICEF and WHO indicates record immunization coverage in South Asia for 2024, with coverage for the third dose of DTP vaccine reaching 92%. India achieved a 43% drop in its "zero-dose" (unvaccinated) children population.

SBI Launches 'Amrit Vrishti' Fixed Deposit Scheme: Available from July 15, 2024, to March 31, 2025, this scheme offers a base interest rate of 7.25% per annum for a 444-day fixed deposit, with an additional 0.50% for senior citizens.

BranchX Launches India's First Personal Loan Solution via ONDC: This neobank launched a digital-first, paperless personal loan product through the Open Network for Digital Commerce, an Indian government initiative.
