Global and Regional Initiatives

The Biodiversa+ Partnership has launched a research call with a budget approximately €40 million to support projects focused on ecosystem restoration. initiative is a direct effort to implement the EU Nature Restoration Law and the EU Biodiversity Strategy for 2030, which aims to help Europe's biodiversity recover.

The 15th Conference of the Parties (COP15) on wetlands, which concluded on this day, adopted the Victoria Falls Declaration. This declaration highlights the importance of healthy wetlands in addressing global challenges like climate change, biodiversity loss, and pollution.

Additionally, the UNESCO Global Geoparks Council met on this day to review and endorse new geoparks, which are areas with geological heritage of international significance. The council proposed adding 12 new geoparks to the network, which aims to combine conservation with sustainable development and community involvement.


