Biodiversity & Conservation:

The High Seas Treaty (BBNJ Agreement)

The Agreement on the Conservation and Sustainable Use of Marine Biological Diversity of Areas beyond National Jurisdiction (BBNJ Agreement) reached its required threshold of 60 ratifications on September 19, 2025. This allows it to enter into force 120 days later, on January 17, 2026. The treaty, the result of nearly two decades of negotiations, provides a legal framework to protect the high seas, which cover nearly two-thirds of the world's oceans.

The BBNJ Agreement's key provisions include:

Establishing marine protected areas (MPAs) on the high seas.

Conducting **environmental impact assessments** for activities in these areas.

Promoting the **fair and equitable sharing of benefits** from marine genetic resources.

Facilitating capacity-building and the transfer of marine technology to developing nations.

This is a significant step toward achieving the "30x30" goal of the Kunming-Montreal Global Biodiversity Framework, which aims to conserve at least 30% of the world's land and sea by 2030.

Other Developments

Goa, India: The Chief Minister of Goa, Dr. Pramod Sawant, emphasized the importance of conserving the state's natural water bodies and biodiversity. He spoke at a session on the "Mission Sarovar Punha Nirman: Reimagining Goa's Lake" initiative, which aims to rejuvenate 39 lakes.

European Wolves: Following a European Parliament vote, the protection status of wolves across Europe has been downgraded from "strictly protected" to "protected." This change, driven by a 58% increase in the wolf population over the past decade, grants member states more flexibility in managing wolf populations. Experts caution that this shift highlights the need for adaptive and transparent wildlife management frameworks to ensure continued species recovery.
