Biotechnology & Health:

Gene Therapy and Drug Approvals

Krystal Biotech's VYJUVEK: Krystal Biotech announced significant progress for its gene therapy, VYJUVEK, which treats Dystrophic Epidermolysis Bullosa (DEB), a rare genetic skin disease. The company received approval from Japan's Ministry of Health, Labour and Welfare, and is preparing for a European launch in Germany and France following an earlier European Commission approval.

Clinical Trials: The company also dosed the first patient in its EMERALD-1 study for the treatment of Neuropathic Keratitis (NK) and provided an update on its Phase 1/2 study for non-small cell lung cancer.

Biotechnology: Puma Biotechnology announced its intention to host a conference call to discuss its second quarter 2025 financial results on July 24, 2025, and also reported recent inducement awards.

Health Technology and Policy

Biotechnology Policy in India: A Union Minister in India urged states to set up "BioE3 Cells" to support the country's biotechnology sector. The BioE3 Policy (Biotechnology for Economy, Environment and Employment) aims to foster high-performance biomanufacturing and boost employment.

Healthtech **Acquisitions:** In the health technology space, Medi Assist Insurance acquired Paramount TPA, and Polymed announced plans for global expansion through new plants and mergers and acquisitions.

AI in Healthcare: The healthcare sector saw several advancements in artificial intelligence. An AI-powered maternal and child care program was rolled out in Rayagada, India, and an AI-led claims platform was launched by Star Health and Medi Assist. ISS AHER and Google Research also teamed up for an AI healthcare breakthrough.

Biomedical Research: India's Defence Research and Development Organisation (DRDO) and AIIMS Rishikesh partnered to conduct clinical trials for biomedical technology.

Regulatory and Market Updates

U.S. US FDA: The Food and Administration's top vaccine regulator resigned, which was followed by the agency launching a "listening tour" to gather input from biopharma leaders on innovation and policy.

Financial News: The biotech sector's financial performance remained a topic of interest, with reports highlighting that emerging biotechs were taking a more "bearish" approach to navigate market trends. Additionally, a new study found that semaglutide (a drug for diabetes and weight loss) may offer better protection against dementia compared to metformin.
