

# HISTORICAL AND TECHNICAL EVENTS OF 3<sup>RD</sup> DECEMBER 2025

1796: Accession of Bajirao II as the Peshwa of the Maratha Empire

On December 3, **1796**, **Bajirao II** acceded to the position of **Peshwa** (Prime Minister) of the **Maratha Empire**. Bajirao II was the **eighth and final Peshwa** of the Maratha confederacy, serving until his defeat in 1818. He was the son of the former Peshwa, **Raghunathrao**, often known as **Raghoba**.

- **Period of Decline:** His tenure is historically recognized as the period during which the Maratha Empire experienced a pronounced decline in power and influence.
- Conflict with the British: The reign of Bajirao II
  was marked by the initiation of significant
  conflicts with the British East India Company,
  culminating in the Third Anglo-Maratha War.
- The Power Vacuum: The political landscape of the time was highly unstable, particularly following the death of his influential Prime Minister, Nana Phadnavis. This event triggered a massive power struggle and a scramble for the deceased minister's vast property and influence, further destabilizing the Peshwa's authority.
- **Deposition:** Ultimately, these factors led to the **removal** of Peshwa Bajirao II from his post, marking the end of the Peshwa rule.

# 1959: Signing of the Gandak Irrigation and Power Project Agreement

In December 1959, a bilateral agreement was formally signed between the governments of India and Nepal for the Gandak Irrigation and Power Project. This joint venture was designed to harness the waters of the Gandak River for mutual benefit,

specifically focusing on irrigation and hydroelectric power generation.

- Barrage Location: The project centers around the construction of a 740-meter-long barrage situated near Valmiki Nagar on the Indo-Nepal border.
- Eastern Main Canal (Tirhut Canal): A critical component is the Eastern Main Canal, also known as the Tirhut Canal. This canal system is instrumental in providing irrigation to several districts within India, including Champaran, Muzaffarpur, Darbhanga, Vaishali, and Samastipur in the state of Bihar, as well as the Parsa and Rautahat districts in Nepal.

# 1967: Launch of India's First Indigenous Sounding Rocket, 'Rohini RH-75'

On December 3, 1967, India achieved a significant milestone in its space program with the successful launch of its first indigenous sounding rocket, the Rohini RH-75. Spardhaguru

- **Development and Organization:** The RH-75 (an abbreviation for Rohini-75) was completely developed by the Indian Space Research Organisation (ISRO).
- Launch Site: The launch was conducted from the Thumba Equatorial Rocket Launching Station (TERLS), located in Thumba, Kerala.
- Strategic Location: Thumba was chosen as the ideal site for this program due to its unique geographical proximity to the magnetic equator, a location that provides optimum conditions for atmospheric and ionospheric research using sounding rockets.

### 1924: Inauguration of the Gateway of India

The Gateway of India, a monumental archway located in Mumbai, was fully constructed and inaugurated in December, 4th 1924.

- **Construction Details:** Prior to the main construction, a sea wall was necessary to protect the foundation of the structure from the sea.
- Architecture and Material: The structure stands at a height of 26 meters (85 feet). It is constructed entirely of local basalt stone and is designed in the style of a triumphal arch, symbolizing victory.
- Official Opening: The formal inauguration ceremony was presided over by the then Viceroy of India, Rufus Isaacs, who held the title of the 1st Marquess of Reading.
- **Current Use:** Today, the Gateway of India serves as a major tourist attraction and a primary point of embarkation for boat **services** that transport visitors to islands in the Arabian Sea, such as Elephanta Island.

#### 1952: First Flight of the Grumman XS2F-1

In December 1952, the Grumman XS2F-1, a prototype for an anti-submarine warfare (ASW) aircraft, successfully conducted its first flight.

- Initial **Procurement:** aircraft's The development was commissioned with an order placed on June 30, 1950, which included two XS2F-1 prototypes along with a concurrent order for 15 S2F-1 production aircraft.
- **Service Entry:** Following the testing phase, the production models, designated S2F-1, officially entered service with the VS-26 squadron of the U.S. Navy in February 1954.



Follow-on Variants and Standardization: The initial design led to the development of several follow-on versions, including the WF **Tracer** (an Airborne Early Warning variant) and the TF Trader (a Carrier Onboard Delivery transport variant). These aircraft were later redesignated in the 1962 triservice designation standardization as the Grumman E-1 Tracer and Grumman C-1 Trader, respectively.

#### NEWS NATIONAL ON3RD DECEMBER 2025



The **Department of Telecommunications (DoT)** has introduced a significant regulatory measure aimed at enhancing telecom cybersecurity and combating digital fraud. This decision, formalized under the Telecommunication Cybersecurity Amendment Rules, 2025, makes it mandatory for all messaging applications, including major platforms like WhatsApp, Telegram, and Arattai, to maintain a constant link to a SIM card installed on the user's device.

# **Key Points:**

- **Active SIM Requirement:** Messaging services will only be accessible when the application is actively and persistently linked to a specific, functioning SIM card present within the user's handset.
- Web Version Security: The web-based counterparts of these applications are now required to enforce periodic logouts of users, with a maximum session duration of six hours. Re-login is strictly restricted to a secure process involving QR code scanning

that must be linked back to the actively registered SIM card.

This amendment is designed to eliminate loopholes in mobile application identification systems, providing a more robust mechanism for tracing and addressing illicit digital activity.

# National News: Record Foodgrain Production Achieved in India

In a historic milestone for the agricultural sector, Prime Minister Narendra Modi announced that India's **foodgrain production** reached an all-time high of **357 million tonnes** in the year 2025. This achievement, highlighted during the 128th edition of his monthly radio address 'Mann Ki Baat,' underscores the nation's increasing trend toward food self-sufficiency and sustained growth in agriculture.

# **Key Points:**

- Output Surge: Foodgrain production demonstrated a substantial decadal growth nearly 40%, escalating approximately **257 million tonnes** in 2015 to the current record of 357 million tonnes in 2025.
- **Drivers of Growth:** This remarkable increase is attributed to a strategic combination of factors, including:
  - Expansion and improvement of irrigation facilities.
  - The adoption of enhanced seed varieties.
  - Increased **mechanization** in farming practices.
  - Direct financial and logistical support schemes for farmers.

### India Re-Elected to the IMO Council

India secured a significant diplomatic victory on the maritime front by being re-elected to the International Maritime Organization (IMO) Council in Category B on November 28, 2025. India garnered 154 out of 169 valid votes, achieving the highest vote tally in its category.

# **Key Points:**

- Global Maritime Recognition: This reelection marks the **second consecutive term** that India has been the top-voted nation in Category B, reaffirming its progressively influential status as a global maritime power.
- Focus Areas: India's renewed mandate is expected to focus on global maritime agenda items, including:
  - Enhancing maritime safety seafarer welfare.
  - Driving decarbonization and sustainability initiatives in the shipping industry.
  - Promoting technological integration and digital shipping systems.
  - Advancing port-led development and the blue economy.

The World Bank Group formally announced the appointment of Paschal Donohoe as its new Managing Director and Chief Knowledge Officer (CKO). Donohoe, who will assume his role in

November 2025, is a highly experienced European policymaker and public servant.

UPI Growth Metrics: transactions demonstrated a year-on-year growth of 23%









- Transaction Volume: As of November 28, UPI successfully processed over 19 billion transactions.
- Transaction Value: The total value of these processed transactions reached ₹24.58 lakh

# III State News (Tamil Nadu): New School for Traditional Folk Arts

- **Educational Development:** Furthermore, the government has plans to launch a new postgraduate (PG) course in this domain starting in the academic year 2026-27.
- Financial Support: Financial assistance provided to the relevant university for this cultural endeavor will be substantially increased from ₹3 crore to ₹5 crore.






