

### Geopolitical Landscape and Defence Spending:

NATO's Increased Defence Spending Targets: At the recently concluded NATO Summit in The Hague (June 24-25, 2025), member countries committed to significantly increasing their defence spending to 5% of GDP over the next 10 years, more than double the previous target of 2%. This new target is subdivided into 3.5% for core defence requirements and 1.5% for wider defence-related This measures. reflects intensifying security challenges, particularly the ongoing conflict in Ukraine and the long-term threat posed by Russia.

Global Military Spending Surge: Global defence spending surged by 8.1% in 2024, reaching an unprecedented \$2.3 trillion. This increase is driven by renewed great-power competition, regional instability (especially in Eastern Europe, the Indo-Pacific, and the Middle East), and a shift away from counterinsurgency focus to deterring peer adversaries.

Public Debt Concerns: The surge in military spending is largely being funded by increased public borrowing, raising concerns about growing public debt levels globally.

Transatlantic Defence Industrial Cooperation: NATO allies are reaffirming their commitment to rapidly expanding transatlantic defence industrial cooperation and harnessing emerging technology to advance collective security, with efforts to eliminate defence trade barriers.

### II. Military Technology Advancements & **Procurement:**

Dominance of Autonomous Systems and AI: Defence. autonomy, cybersecurity, and aerospace innovation continue to define global security discussions. Conferences and events in July 2025 are focusing heavily on military robotics, uncrewed maritime operations (ASVs, undersea drones), and AI integration for battlefield autonomy, lethal decision-making, and logistics.

Demand for Drone Operators Soaring: The Royal Australian Artillery, among other forces, is experiencing a significant increase in demand for drone operators due to the shift to advanced uncrewed aerial systems (UAS) like the Integrator tactical uncrewed aerial system, which offers enhanced intelligence, surveillance, reconnaissance, and targeting capabilities.

New Delivery Vehicles for Military Aid: The ASD-Connect platform is being launched to integrate Ukraine's defence industry into the European ecosystem, providing direct and secure access for Ukrainian manufacturers to European partners.

Hackathons for Defence Tech: Events like the European Defense Tech Hackathon and AI Data Jam Hackathon are bringing together engineers and government representatives to develop solutions, for example, for automatically detecting explosive objects in drone imagery.

Cryo-Electron Microscopy (Cryo-EM) and MagIC Technology: advanced These technologies continue to be crucial for understanding diseases, drug design,



analyzing biomarkers, indirectly supporting military health and biological defense efforts.

### III. India-Specific Defence News (as of July 15, 2025):

Apache Helicopter Delivery to Indian Army: The U.S. is set to deliver the first batch of three AH-64E Apache attack helicopters to the Indian Army on July 15, 2025. This long-delayed delivery (originally May-June 2024) aims to enhance ground-attack capabilities, particularly in regions like Ladakh. The Indian Army Aviation Corps had already established its first Apache squadron (451st Aviation Squadron) in anticipation.

Indigenous UAV Development: Solar Defence and Aerospace Limited (SDAL) has been shortlisted to develop a 150 kg category Light Medium-Unmanned Aerial Vehicle (LM-UAV) for the Indian Army. This loitering munition aims for precision strikes, ISR, and high-altitude operations, with over 75% indigenous content aligning with the 'Aatmanirbhar Bharat' initiative. Key features include a 900 km range, 9 hours endurance, 5 km altitude, and stealth capabilities.

Akash Missile System Development (Brazil-India Talks): Brazil has terminated negotiations with India for the Akash-1S surface-to-air missile system, opting for Italy's EMADS system. Brazil sought a system capable of intercepting threats above 3,000 meters, which Akash-1S lacked. The Indian Defence Research Wing (idrw.org) reports that India is reconsidering and may offer the more advanced Akash-NG (New Generation) system to Brazil, which offers superior range (70-80 km), a 360° launch capability from canisterized systems,

and an AESA seeker. Akash-NG is currently undergoing final user trials and is expected to enter serial production in 2-3 years.

### Pahalgam Terrorist Attack (Jammu & Kashmir):

A detailed investigation has revealed that the April 22 terrorist attack in Pahalgam, which killed 26 civilians, was a conspiracy hatched by Pakistan's ISI and Lashkar-e-Taiba (LeT), executed exclusively by Pakistani foreign terrorists to maintain secrecy and minimize local involvement.

**Naval Contracts:** The U.S. Department of Defense announced several significant contracts, including for Rolls-Royce Corp. for MT7 turboshaft engines for Ship to Shore Connector programs, Black Hills Ammunition Inc. for 5.56mm ammunition, Lockheed Martin for F/A-18 aircraft components, and The Boeing Co. for EA-18G platform support. Global Pacific Design Builders LLC was awarded a substantial contract for housing units at Andersen Air Force Base Guam rivate Limited

### IV. Major Defence Exercises:

Exercise Shakti 2025 (India-France): The 8th edition of "Exercise Shakti," a biennial joint military exercise between India and France, was held from June 18 to July 1, 2025, at La Cavalerie France. It focused on multi-domain operations in a sub-conventional (counterterrorism) scenario, enhancing interoperability.

Talisman Sabre 2025 (Multinational, led by Australia): India, along with 18 other nations, is participating in Talisman Sabre 2025, a major bilateral military drill led by Australia that commenced on July 13, 2025. This 11th iteration is the largest and most sophisticated warfighting exercise ever conducted ipa<sub>a</sub>
