# Defence news

On August 27, 2025, several key developments in defense were reported, both in India and internationally.

#### **Indian Defence News**

**GE Fighter Jet Engines:** India is finalizing a \$1 billion deal with U.S. aerospace company General Electric (GE) for the supply of 113 F404-IN20 fighter jet engines. These engines are intended to power India's indigenous Light Combat Aircraft (LCA) TEJAS MK-1A.

INS Udaygiri and INS Himgiri: Defence Minister Rajnath Singh stated that India will no longer depend on foreign shipbuilding for its Navy. He made this announcement while commissioning two new, indigenously constructed warships, INS Udaygi<mark>ri and INS Himg</mark>iri. These are the 100th and 101st warships designed in-house by the Indian Navy.

"Sudarshan Chakra" Air Defence Shield: India is embarking on a mission to build a multi-layered, AIpowered integrated air and missile defense shield called "Mission Sudarshan Chakra." This system is being developed to protect strategic and vital civilian areas. Under Project Kusha, India is scheduled to begin testing new long-range interceptor missiles for the shield next year.

MoU for Veterans: The Defence Ministry signed a Memorandum of Understanding (MoU) with the Quality Council of India (QCI) to enhance services for over 63 lakh veterans and their dependents. The MoU will facilitate digital evaluations and evidencebased policy recommendations for services like pensions and healthcare.

Military Exercise: India is sending over 700 personnel to particiate in a biennial multilateral exercise in Egypt called "Exercise Bright Star." The exercise, which also includes the U.S., will run from

August 28 to September 10, 2025, and focuses or enhancing joint planning and interoperability.

#### International Defence News

**U.S. Foreign Military Sales:** The U.S. Department of State approved a potential Foreign Military Sale to the NATO Support and Procurement Agency (NSPA) for AIM-9X Sidewinder Missiles and related equipment for an estimated cost of \$103.9 million. These missiles are for the F-35 fleets of Belgium, Italy, and Romania.

Iran Update: The E3 (the United Kingdom, Germany, and France) are reportedly planning to initiate the Joint Comprehensive Plan of Action (JCPOA) snapback process as soon as August 28. This mechanism would reimpose UN Security Council (UNSC) sanctions on Iran due to a lack of progress on a nuclear deal.

**Polish F-35 Sustainment:** The U.S. State Department also approved a possible Foreign Military Sale to Poland for F-35 Sustainment for an estimated cost of \$1.85 billion.




