


### **Key Scheme Updates**

Pradhan Mantri Awas Yojana - Gramin (PMAY-**G):** The central government has allocated 4.12 crore houses to states and union territories under this scheme to provide affordable housing for rural families.

India Semiconductor Mission (ISM): The Union Cabinet has approved four new semiconductor projects worth ₹4,594 crore. These projects aim to strengthen India's semiconductor ecosystem and contribute to the "Atmanirbhar Bharat" initiative.

Pradhan Mantri Viksit Bharat Rozgar Yojana (PM-VBRY): This scheme, which came into effect on August 1, 2025, aims to incentivize the creation of over 3.5 crore jobs in the country. It incentives both first-time provides to employees and employers.

PM-YUVA 3.0: The latest phase of this mentorship scheme for young authors has been launched. It focuses on promoting reading, writing, and Indian literature globally, with scholarships and mentorship provided to selected authors under the age of 30.

## Other Noteworthy Schemes

PM-Surya Ghar: Muft Bijli Yojana: This scheme provides a subsidy for households to install rooftop solar panels to get free electricity.

Pradhan Mantri Jan Arogya Yojana (PM-JAY): A flagship health insurance scheme that provides a health cover of ₹5 lakh per family per year for secondary and tertiary care hospitalization.

Pradhan Mantri Kisan Samman Nidhi (PM-**KISAN):** A scheme that provides financial assistance to eligible farmer families.

Jal Jeevan Mission: A program aimed at providing safe and adequate drinking water to rural households through individual household tap connections.
