Govt schemes

Several Indian government schemes are in the of August 28, 2025, news as updates, anniversaries, policy and new initiatives.

PM SVANidhi Scheme Restructuring

The Union Cabinet has approved a major restructuring and extension of the Pradhan Mantri Street Vendor's AtmaNirbhar Nidhi (PM SVANidhi) scheme. The program has been extended until March 31, 2030, with a total outlay of ₹7,332 crore. This revamped scheme aims to benefit 1.15 crore beneficiaries, including 50 lakh new street vendors. Key changes include:

Enhanced Loan Amounts: The first loan tranche has been increased to ₹15,000 (from ₹10,000) and the second to ₹25,000 (from ₹20,000). The third tranche remains at ₹50,000.

UPI-linked Credit Cards: Beneficiaries who repay their second loan will be eligible for a UPIlinked RuPay credit card to assist with both business and personal needs.

Pradhan Mantri Ian Dhan Yojana (PMIDY) Anniversary

The Pradhan Mantri Jan Dhan Yojana (PMJDY), a national mission for financial inclusion, completed 11 years on August 28, 2025. Launched on August 28, 2014, the scheme aims to provide universal access to banking services, including basic savings accounts, credit, insurance, and pension facilities. The program has been instrumental in bringing millions of

unbanked households into the formal financial system. The Guinness World Records has also recognized the scheme for opening the most bank accounts in a single week.

New and Ongoing Initiatives

Pradhan Mantri Viksit Bharat Rozgar Yojana: This new employment-linked incentive scheme, approved by the Union Cabinet, aims to provide comprehensive employment support. It offers a direct incentive of up to ₹15,000 to new entrants in the formal workforce who register with the EPFO. The scheme is expected to generate over 3.5 crore jobs within two years.

20th Instalment of PM-KISAN: The 20th instalment of the Pradhan Mantri Kisan Samman Nidhi (PM-KISAN) scheme is set to be released. This initiative provides direct financial assistance to small and marginal farmers, with over 9.7 crore farmers expected to receive funds.

Export Promotion Mission: A support package worth ₹25,000 crore has been proposed under the new Export Promotion Mission (EPM). The mission aims to strengthen Indian exporters, particularly Micro. Small, and Medium Enterprises (MSMEs), by providing affordable credit, improving market access, and assisting with capacity building.

Semiconductor Mission: The India Semiconductor Mission (ISM) continues to be a focus area, with the government approving new projects and plans for the fourth edition of the SEMICON India 2025 conference. The mission provides fiscal support to build a robust semiconductor and display ecosystem in the country.
