# Govt schemes

### **Key Updates on Existing Schemes**

Registered Post and Speed Post Merger: The Department of Posts (DoP) has merged its domestic Registered Post and Speed Post services, with the change effective from today, September 1, 2025. This means all domestic registered mail will now be handled and delivered as Speed Post.

Jan Dhan Yojana and Financial Inclusion: The government's nationwide financial inclusion saturation campaign, which began on July 1, 2025, is ongoing and will run until September 30, 2025. This campaign aims to bolster the outreach of schemes like the Pradhan Mantri Jan Dhan Yojana (PMJDY), Pradhan Mantri Jeevan Jyoti Bima Yojana (PMJJBY), and Pradhan Mantri Suraksha Bima Yojana (PMSBY) by holding camps across Gram Panchayats and Urban Local Bodies. This initiative is to ensure comprehensive coverage and facilitate new account openings, re-verification of KYC details, and promote financial literacy.

#### New Announcements and Initiatives

Chief Minister Women's Employment Scheme (Bihar): The Bihar Cabinet has approved a new scheme to provide financial assistance to women. Under the "Chief Minister Women's Employment Scheme," a first installment of Rs. 10,000 will be provided to one woman from every family in the state to start a new business venture. The transfer of funds is set to begin in September 2025.

New Union Budget Schemes (as announced in Budget 2025): Several new schemes and modifications to existing ones were announced earlier in the year as part of the Union Budget 2025, with implementation and funding now in progress:

"Prime Minister Dhan-Dhaanya Krishi Yojana": This program, in partnership with states, aims to enhance agricultural productivity and promote sustainable practices for around 1.7 crore farmers.

"Rural Prosperity and Resilience Programme": multi-sectoral program address agricultural underemployment through investment, technology, and skill development.

"Mission for Aatmanirbharta in Pulses": A sixyear mission to achieve self-reliance in pulses, on climate-resilient seeds improved post-harvest management.

Modified UDAN Scheme: The modified UDAN scheme aims to enhance regional connectivity to 120 new destinations and support smaller airports and helipads in remote areas.

**Increased Credit for MSMEs:** The government has enhanced the credit guarantee fund for Micro, Small, and Medium Enterprises (MSMEs) and startups to improve access to credit. For micro and small enterprises, the limit has been increased from Rs. 5 crore to Rs. 10 crore. For startups, the limit has been raised from Rs. 10 crore to Rs. 20 crore.


