

## Govt schemes

Government schemes announced or updated on September 20, 2025, include the launch of the Angikaar 2025 campaign under the Pradhan Mantri Awas Yojana-Urban (PMAY-U) 2.0, the launch of Rashtriya Poshan Maah for 2025, and a new directive from the Pension Fund Regulatory and Development Authority (PFRDA) concerning the Unified Pension Scheme (UPS). Additionally, a regional summit focused on schemes for MSMEs was held in Nashik, and the Supreme Court approved the new constitution for the All India Football Federation (AIFF).

#### National Campaign and Social Welfare

Angikaar 2025: This two-month nationwide campaign was launched under the Pradhan Mantri Awas Yojana-Urban (PMAY-U) 2.0 to fast-track the verification of applications and the completion of houses. The campaign aims to ensure the "Housing for All" goal is met and includes special drives to extend benefits from other schemes, such as the PM Surya Ghar: Muft Bijli Yojana.

Rashtriva Poshan Maah 2025: Prime Minister Narendra Modi launched the 8th edition of the Rashtriya Poshan Maah (National Nutrition Month) along with the Swasth Nari Sashakt Parivar Abhiyan. This initiative aligns with the vision of "Sashakt Nari" (Empowered Women) and "Suposhit Bharat" (Nourished India). It aims to combat malnutrition by promoting dietary diversity and community engagement.

#### Financial and Regulatory Updates

Unified Pension Scheme (UPS): The PFRDA issued a circular on September 16, 2025, to allow central government employees facing technical glitches to submit their UPS option forms physically. The deadline to opt for this scheme, which offers a one-time option for those who joined after April 1, 2025, is September 30, 2025.

Schemes for MSMEs: A regional summit for Micro, Small, and Medium Enterprises (MSMEs) in Nashik, Maharashtra, focused on the need for businesses to adopt new technologies and digitalization. The discussion highlighted how existing schemes, such as the Credit Guarantee Scheme, are being used to support MSMEs in contributing to the vision of a "Viksit Bharat" (Developed India) by 2047.

**GST Council Reforms**: The 56th GST Council announced major changes effective September 22, 2025. The previous four-slab system is being replaced with a streamlined two-rate structure: a 5% rate for essential goods and an 18% standard rate for most other goods and services.

### Sports & Youth Development

AIFF **Constitution**: The Supreme approved the new draft constitution for the **All** India Football Federation (AIFF). This is a significant step towards bringing Indian football governance in line with global standards.

**PM-YUVA 3.0 Scheme**: While not a new launch. the evaluation phase for this scheme to mentor young authors concluded on September 15, 2025. The initiative, which is part of PM Modi's vision to promote reading and writing, will
