PM-KISAN Scheme Disbursement: Prime Minister Narendra Modi is scheduled to release the 20th installment of the Pradhan Mantri Kisan Samman Nidhi (PM-KISAN) scheme from This installment will disburse Varanasi. approximately ₹20,500 crore directly to over 9.7 crore farmers across the country.

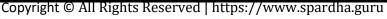
