Independence Day Preparations: Security has been significantly tightened across the country, especially in Jammu and Kashmir, ahead of the upcoming Independence Day celebrations.

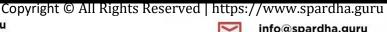
DRDO Guest House Manager Arrested: A guest house manager at DRDO in Jaisalmer has been arrested for allegedly spying for Pakistan's ISI.
