National News

Politics and Governance

PM Modi's Visit: Prime Minister Narendra Modi is on a visit to Bihar and West Bengal today to inaugurate and lay the foundation stone for several development projects. In Bihar, the focus is on infrastructure, including bridges, roads, power plants, and health facilities. In West Bengal, he will inaugurate new metro sections in Kolkata, which are expected to significantly reduce travel time.

Parliamentary Session Concludes: The Monsoon Session of Parliament has concluded, with both the Lok Sabha and Rajya Sabha being adjourned sine die. The session was described as fruitful by Union Minister Kiren Rijiju, despite protests from the Opposition.

Online Gaming Bill: The "Promotion and Regulation of Online Gaming Bill, 2025" has been passed by the Rajya Sabha, following its passage in the Lok Sabha. The bill aims to ban online games that involve real money and has been sent to the President for her assent.

Vice-Presidential The Election: Election Commission of India has appointed two observers for the upcoming Vice-Presidential Election. The NDA's nominee for the position is C.P. Radhakrishnan, while the INDIA Bloc has nominated B. Sudershan Reddy.

GST Reforms: A Group of Ministers on GST rate rationalization has accepted the Centre's proposal to restructure the GST system by reducing the number of slabs to two: 5% and 18%. The proposal, which would scrap the 12%

and 28% slabs, will now be recommended to the GST Council for a final decision.

Economy and Business

Biofuels Promotion: Union Minister Petroleum and Natural Gas, Hardeep Puri, stated that the government has made significant progress in promoting biofuels as a sustainable alternative to petroleum products.

Economic Growth and Credit Ratings: Following a recent sovereign rating upgrade, Indian bonds are seeing a historic tightening of credit spreads abroad, reflecting robust overseas interest in India's economy. This indicates acceptability and cheaper funding costs for Indian companies in the international market.

Online Gaming Industry Impact: Following the passage of the Online Gaming Bill, shares of companies in the sector, such as Nazara Technologies, have dropped significantly due to the ban on real-money gaming.

Other Important Developments

Weather Forecast: The India Meteorological Department (IMD) has forecasted heavy to very heavy rainfall in several states, including Arunachal Pradesh, Bihar, East Rajasthan, and West Bengal. Heavy rain has already lashed parts of Chennai.

ISRO's Gaganyaan Mission: The Indian Space Research Organisation (ISRO) has announced that the first test flight for India's maiden space mission, Gaganyaan, is scheduled for December of this year.

Indian Railways: **Railways** Indian announced plans to operate 380 special trains




