

#### **Government and Politics**

**RSS Lecture Series:** Rashtriya Swayamsevak Sangh (RSS) chief Mohan Bhagwat is scheduled to begin a three-day lecture series in New Delhi to outline the organization's 100-year journey and its vision for India. The event, part of its centenary year outreach program, is expected to be attended by around 1,300 people from various fields.

Submarine Deal: The central government has given clearance for the Ministry of Defence and Mazagon Dock Shipbuilders Limited (MDL) to begin negotiations for a significant submarine deal worth around ₹70,000 crore. The deal involves building six submarines in India with German support under 'Project 75 India'.

**Pension Scheme: The Union Finance Ministry** has introduced a one-time, one-way switch facility, allowing individuals to move from the newly launched Unified Pension Scheme (UPS) to the National Pension System (NPS).

**Online Gaming Bill:** President Droupadi Murmu has given her assent to the Promotion and Regulation of Online Gaming Bill, 2025. The bill aims to encourage e-sports and online social games while prohibiting online money gaming.

Sudarshan Chakra Air Defence System: India has successfully conducted the first firing tests of a new Integrated Air Defence Weapon System (IADWS) named "Sudarshan Chakra." The multi-layered system is designed to neutralize a range of aerial threats, from aircraft and

missiles to drones, using missiles and highpowered lasers.

**Naval Ships:** Two new naval ships, INS Udaygiri and INS Himgiri, are scheduled to be inducted into the Indian Navy's fleet.

#### Other National News

**Weather:** The India Meteorological Department (IMD) has issued rain alerts for several regions across the country, including Jharkhand, Gujarat, Rajasthan, and parts of the Northeast due to widespread monsoon activity. Warnings have been issued for potential flooding, waterlogging, and travel disruptions.

Ganesh Chaturthi: August 26 marks the beginning of the Ganesh Chaturthi festival, with the Chaturthi Tithi starting in the afternoon. The festival will culminate with Ganesh Visarjan on September 6.

Trade Tensions: The US has officially notified India of additional tariffs on Indian goods, set to take effect on August 27, citing India's purchase of Russian crude oil. In response, Prime Minister Narendra Modi has stated that India will withstand the economic pressure and continue to strengthen its resilience, emphasizing support for small entrepreneurs and farmers.

**All India Speakers' Conference:** A special commemorative stamp was released by Union Minister Amit Shah to mark the 100th anniversary of Vitthalbhai Patel becoming the first elected Indian Speaker of the Central Legislative Assembly.




