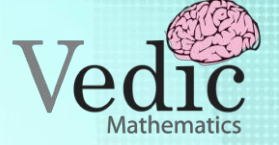

National News

Disasters and Weather:

Flooding and Landslides: Several states in North India, including Jammu and Kashmir, Himachal Pradesh, and Uttarakhand, are grappling with the aftermath of heavy rainfall, flash floods, and landslides.

Union Home Minister Amit Shah is in Jammu to assess the flood situation and chair a high-level meeting on relief measures.

A red alert for "extremely heavy rains" has been issued for multiple districts in Himachal Pradesh and Uttarakhand. Schools have been closed in many districts.

Rahul Gandhi's 'Voter Adhikar Yatra': Congress leader Rahul Gandhi's "Voter Adhikar Yatra" is set to conclude with a foot march in Patna.

Economy and Finance:

GDP Growth: India's Gross Domestic Product (GDP) grew at 7.8% in the April-June quarter of the financial year 2025-26, which is a five-quarter high. This growth was reportedly boosted by a rise in public capital expenditure.

Change in Financial Rules: Several financial rules and deadlines are coming into effect this month:

The Department of Posts has merged its domestic Registered Post and Speed Post services.

Oil marketing companies have reduced the price of commercial LPG gas cylinders.

The deadline for filing Income Tax Returns (ITR) for taxpayers not required to get their accounts audited has been extended to September 15, 2025.

Dedicated Freight Corridor: The Eastern and Western freight corridors have registered a 47% increase in freight train operations in 2024-25.

Badminton: Indian shuttlers Satwiksairaj Rankireddy and Chirag Shetty secured a medal for India at the World Championships by defeating their Malaysian rivals in the men's doubles quarterfinals.

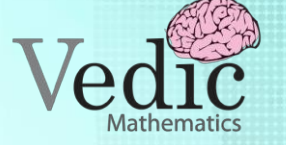
