Supreme Court Dismisses Plea Against Ethanol-Blended Petrol: The Supreme Court of India dismissed a petition that challenged the nationwide rollout of 20% ethanol-blended petrol (EBP-20). The court stated the initiative aligns with India's energy transition and climate goals, and refused to stay the policy.




