Finance: Finance Minister Nirmala Sitharaman stated that India will continue to purchase oil from sources that suit the country's national interests, including Russia.

Infrastructure: The government plans to invest an estimated ₹80 lakh crore to transform India's maritime sector by 2047, with a focus on enhancing port capacity, shipping, shipbuilding, and inland waterways.

Taxation: The GST Council has approved a new two-tier tax structure of 5% and 18%, replacing the previous four-tier system. 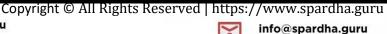
