Political and Diplomatic Events

India and US Relations: Prime Minister Narendra Modi has stated that India and the U.S. are "close friends and natural partners." Both about successful optimistic outcomes from ongoing trade negotiations.

Vice President-elect: C.P. Radhakrishnan, the NDA candidate, has been elected as the new Vice-President of India, describing his win as a "victory of the nationalistic ideology."

Nepal Situation: Following the resignation of Nepal's Prime Minister amid violent protests, India has expressed concern and PM Modi has presided over a meeting of the Cabinet Committee on Security to discuss the developments. Indian airlines have canceled flights to Kathmandu.

India-Israel Agreement: The Indian government has signed a Bilateral Investment Treaty (BIT) with Israel to boost bilateral investments and strengthen relations.

Anokhi Duniya Park: The Uttar Pradesh government has launched a park called 'Anokhi Duniva,' which is claimed to be the world's first park made entirely from ceramic waste.

ISRO's Achievements: The Indian Research Organisation (ISRO) has announced that India has secured nine major world records in space exploration and is on track to add 8 to 10 more in the coming years.

UPI-UPU Integration: Union Minister Iyotiraditya Scindia has launched the "UPI-UPU integration project" in Dubai, which will use India's Unified Payments Interface (UPI) and the Universal Postal Union (UPU) Interconnection Platform to facilitate crossborder payments are Limited

EV Testing Facility: A new state-of-the-art EV testing facility is set to be inaugurated by Union Minister Prahlad Joshi in New Delhi.
