

National News

Political and Government Developments:

ITR Filing Deadline Extended: The Central Board of Direct Taxes (CBDT) has extended the deadline for filing Income Tax Returns (ITRs) for Assessment Year 2025-26 by one day, to September 16, due to technical glitches on the efiling portal. A record 7.3 crore ITRs were filed by the previous deadline.

Supreme Court Ruling: The Supreme Court has refused to entertain a petition seeking to bring registered political parties under the ambit of the Sexual Harassment of Women at Workplace (Prevention, Prohibition, and Redressal) Act, 2013 (POSH Act). The court stated that a political party cannot be considered "workplace" in the same sense as a commercial establishment.

PM Modi's address in Bihar: Prime Minister Narendra Modi, while addressing a public meeting in Bihar's Purnea, reiterated the NDA government's commitment to freeing regions like Bihar, West Bengal, and Assam from "intruders." He also highlighted the recent GST reforms and the inauguration of development projects worth over Rs 40,000 crore in the state, including the Purnea airport and the National Makhana Board.

Mauritius PM's Visit: The Prime Minister of Mauritius, Dr. Navinchandra Ramgoolam, has arrived in New Delhi on his first bilateral visit to India in his current term.

Trade Talks with the US: India is hosting US trade negotiators in New Delhi to discuss and resolve issues related to high tariffs.

Congress on Great Nicobar Project: Congress leader Jairam Ramesh has raised "core concerns" about the Great Nicobar Mega Infrastructure Project, claiming it will displace tribal communities and threaten their survival.

Other Major News:

Defence Minister Pays Tribute: Defence Minister Rajnath Singh has paid tribute to Param Vir Chakra awardee Lt. Col. Tarapore on "Balidan Diwas," hailing his bravery during the 1965 war.

Heavy Rainfall Forecast: The India Meteorological Department (IMD) has forecasted heavy to very heavy rainfall at isolated places across several states, including the North-Eastern states, Bihar, Jharkhand, and parts of Maharashtra and West Bengal.

CBI Raids: The Central Bureau of Investigation (CBI) has conducted raids at 16 locations in Karnataka and Andhra Pradesh in connection with a tribal welfare scam amounting to ₹84.63 crore.

EAM's Greetings: Minister of External Affairs, Dr. S. Jaishankar, has extended greetings to Papua New Guinea and Mexico on their respective Independence Days, emphasizing growing bilateral ties.

Manipur Highway Update: The Kuki-Zo Council has rescinded a pact to reopen National Highway-2 in Manipur and has stated that the highway will not be reopened until a settlement is reached between the Meitei and Kuki-Zo communities.




