

Today in History on 01 APR

> 1979 - Iran declared a Muslim Republic.

In 1979, as a result of a popular uprising in Iran, the monarchy collapsed and an Islamic Republic was established under the leadership of Ayatollah Ruhollah Khomeini. The main reasons for this revolution were the policy of Iran's Pahlavi rulers to imitate and follow the West and the government's failed economic management. Soon after this, the new ruler of Iraq, Saddam Hussein, fearing the outbreak of an Iran-backed Shia movement in his country, attacked Iran, which lasted for 8 years and ended inconclusively.

celebrated as "Utkala Diwas" or "Odisha Day". The Kalinga War of the 3rd century BC was fought in Odisha, which inspired Emperor Ashoka to adopt non-violence and the teachings of the Buddha. In 1935, on April 1, the Reserve Bank of India (RBI) began operations under the Reserve Bank of India Act, 1934, becoming the central bank of India. The RBI was initially a privately owned institution but was later transferred to the ownership of the Government of India. The original share capital was divided into 100 fully paid shares. The RBI was nationalized on January 1, 1949, about a year and a half after India's independence.

1933 Indian Air Force established in Karachi, Pakistan.

The Indian Air Force was officially established on 8 October 1932. Its first AC Flight came into being on 01 April 1933 with six RAF-trained officers and 19 Hawai Sepoys (airmen). Four and a half years later, "A" Flight was in action for the first time from Miranshah in North Waziristan to support Indian Army operations against the rebellious Bhittani tribesmen. Meanwhile, in April 1936, a "B" Flight was also formed on vintage Wapiti.



> 1976 - Doordarshan was separated from All India Radio and Doordarshan Corporation was established.

In 1976, Doordarshan was separated from All India Radio and Doordarshan Corporation established. Radio broadcasting in India began in 1927 with two private transmitters in Mumbai and Kolkata. It was nationalized in 1930 and then it was named Indian Broadcasting Service (Indian Broadcasting Corporation). Later in 1957, it was renamed as All India Radio.
