## Today in History on 17 FEB

> 1698 - Aurangzeb captured the fort of Gingee.

Gingee remained under Maratha domination for 22 years. Mughal emperor Aurangzeb, who made extensive efforts to consolidate the Mughal empire in the Deccan, had a long and protracted struggle with Shivaji's second son Rajaram. During his war with the Mughals, Rajaram stayed in Gingee fort which became the capital of the Marathas for some time. After a siege of about 8 years, Mughal general Zulfigar Khan finally captured Gingee in 1698 AD. Under the Mughals, Gingee was again given a new name, Nusratgarh,



1959 - The first weather satellite called Vanguard 2 was launched into orbit.

Vanguard 2 was the first weather satellite launched by NASA on February 17 in the year 1959. Vanguard 2 was designed to measure cloud cover and resistance, but due to a poor rotation axis and its

elliptical orbit it could only collect a remarkably large amount of useful data. The first successful operational weather satellite is TIROS-1.



> 1947 - 'Voice of America' started broadcasting in the Soviet Union.

Voice of America (VOA) started radio broadcasting in the Soviet Union on February 17, 1947. VOA started its first radio broadcast with the words 'Hello! This is New York calling'. Its purpose was to broadcast news of the Second World War going on in Europe at that time. During the Cold War, VOA was placed under the United States Information Agency. In the 1980s, VOA also started Doordarshan service.



1933 - American weekly magazine 'Newsweek' was published.

1882 - The first Test match is played at the Sydney Cricket Ground.

One of the oldest Test venues, the Sydney Cricket Ground (SCG) hosted its first Test in 1882, an Ashes match between Australia and England. The Sydney Cricket Ground (SCG) is a sports stadium located in the Moore Park suburb of Sydney, New South Wales, Australia. It is used for Test, One Day International and Twenty20 cricket, as well as Australian rules football and occasionally rugby league, rugby union and association football.

Constantine **Tassoulas** Elected Greece's New President

On February, 2025, the Hellenic Parliament elected Constantine Tassoulas, the former parliamentary speaker, as the new president of Greece. Tassoulas, a senior member of the ruling New Democracy party, secured 160 votes in the 300-seat parliament. He will take over from Katerina Sakellaropoulou, Greece's first female president, whose term ends in March. The position of president in Greece is largely ceremonial, but the selection reflects the political direction of the country's leadership.

#### Ilie Bolojan **Assumes** Role as Romania's Interim President

Ilie Bolojan, the President of the Senate, has been sworn in as Romania's interim President following the resignation of Klaus Iohannis. This political shift comes at a time of uncertainty as the country prepares for new presidential elections in May 2025.



### > Jotham Napat Becomes Vanuatu's **New PM**

Jotham Napat was elected as Vanuatu's new Prime Minister, securing the position unopposed. His nomination was proposed by Charlot Salwai, leader of the Reunification Movement for Change and a former prime minister. Ishmael Kalsakau, another former prime minister and MP for Port Vila, confirmed there were no other nominations and congratulated Napat on his election.



### Saab & HAL Join Forces for Advanced Laser Warning System in India

Swedish defence firm Saab has signed a Memorandum of Understanding (MoU) with Hindustan Aeronautics Limited (HAL) to collaborate on the Electronic Warfare Laser Warning System-310 (LWS-310). The agreement, signed on February, 2025, focuses on strengthening India's defence sector by allowing HAL to manufacture the advanced laser warning system domestically. This move aligns with the 'Make in India' initiative and aims to enhance self-reliance in critical defence technology.

This move highlights Temasek's growing interest in India's financial sector and AU Small Finance Bank's rising prominence. The Jaipur-based bank is the largest small finance bank in India, serving retail, micro, small, and medium enterprises (MSMEs) with a strong presence across the country.


