

> 1949 - Jharkhand Party was founded in India.

Jharkhand Party (JP) is one of the oldest political parties in India. It was formed on 5 March 1949 in Ranchi by Marang Gomke Jaipal Singh Munda. The party was formed to demand a separate Jharkhand state. Jharkhand Party participated in the 1952, 1957 and 1962 Bihar Legislative Assembly elections. For more than 15 years, Jharkhand Party was the only major opposition political party against the Indian National Congress in Bihar.

In 1980, Hawke resigned his roles as President of the ACTU and the Labor Party to announce his intention to enter parliamentary politics and subsequently elected to the Australian House of Representatives as the Member of Parliament (MP) for the Division of Wills at the 1980 federal election. Three years later, he was elected unopposed to replace Bill Hayden as leader of the Australian Labor Party and within five weeks led Labor to a landslide victory at the 1983 election and was sworn in as Prime Minister.

➤ 1691 Currency note printed for the first time in Europe.

In 1691, a paper note was printed for the first time in Europe. This note was issued by the Bank of Sweden. Since then, paper notes started being used all over the world. Before Sweden, the kings of China had issued paper bills in the 6th, 9th, and 11th centuries. However, these were not used among the common people. The first paper note in India was issued by the British in 1862. It had a picture of British Queen Victoria on it.



➤ 1824 The First Anglo-Burmese War began.

War was formally declared on Burma on 5 March 1824. On 17 May, the Burmese army attacked Chittagong and drove off a mixed contingent of police and sepoys (natives employed in the Foreign Legion) from their post at Ramu, but could not sustain its success. The Burmese had expanded their influence in Assam. The British had to open up new markets for trade. The British had to counter French influence.








