## > 1627: Death of Mughal ruler Jahangir.

Jahangir died on his way back from Kashmir in 1627 at a place called Bhimwar.

Jahangir was born on 31 August 1569 in Fatehpur Sikri in present-day Uttar Pradesh to Mughal emperor Akbar and his wife Mariam-uz-Zamani.

Jahangir was named Mirza Noor-ud-Din Beg Mohammad Khan Salim and was simply known as Prince Salim. When he took over the Mughal throne, he assumed the title of Jahangir (world conqueror).



# ➤ 1829: Lord William Bentinck, Governor General of the East India Company, took the initiative to end the practice of Sati.

In the year 1829, Lord William Bentinck, Governor General of the East India Company, took the initiative to end the practice of Sati.

Bentinck abolished the practice of Sati in 1829 with the help of Raja Rammohan Roy. Bentinck made a law against this practice and declared the practice of Sati of widows illegal through Section 17 in 1829.



## ➤ 1895: Physicist Wilhelm Conrad Röntgen discovers X-rays.

Wilhelm Conrad Röntgen was a German mechanical engineer and physicist who produced and detected electromagnetic radiation in the wavelength range known as X-rays on November 1895, an achievement that earned him the inaugural Nobel Prize in Physics in 1901.

Mary Robinson served as President of Ireland between 1990 and 1997. The first female president of Ireland, Robinson was exceptionally popular in her role, becoming the most popular president in Irish history.

Prior to her election, Robinson served seven terms as a senator, and alongside her time in Seanad Éireann she also worked as a lawyer and an academic. Robinson resigned early from the presidency to take up the position of High Commissioner for Human Rights with the United Nations.

#### Gogabeel Lake in Bihar Declared Newest Ramsar Site

Gogabeel Lake, located in the Katihar district of Bihar, has been officially designated a Ramsar site, gaining global recognition as a wetland of international importance. With this, India adds yet another name to its growing list of protected wetlands under the Ramsar Convention, strengthening its commitment to wetland conservation and biodiversity protection.



#### Geographical Points:

- Located in the Katihar district of Bihar, it was declared the first community sanctuary in Bihar, reflecting community participation in its conservation.

#### ➤ India Exports Fortified Rice to Costa Rica

In a landmark step that merges health, technology, and international trade, India has exported its first consignment of fortified rice kernel (FRK) to Costa Rica. This 12-metric tonne shipment from Chhattisgarh, facilitated by the Agricultural and Processed Food Products Export Development Authority (APEDA), marks a new chapter in India's agricultural exports. It also strengthens the country's role in combating malnutrition globally, aligning with the domestic Kuposhan Mukt Bharat mission.



#### **Key Points:-**

- Fortified rice kernels are made by combining rice flour with important micronutrients like iron, folic acid, and vitamin B12.
- They are then shaped into rice kernels through a process called extrusion and mixed with regular rice in a specific ratio.

#### India to Resume Approvals for Chinese Imports After Five-Year Freeze

In a significant policy shift, India is set to resume approvals for importing goods from China and other countries, ending a five-year freeze imposed after border tensions escalated in 2020. According to government sources, the move is part of a larger strategy to ease supply chain disruptions, support domestic industries, and meet surging consumer demand, particularly following recent Goods and Services Tax (GST) reductions.
