
➤ 1826- Raja Laxman Singh, a famous writer associated with the history of Hindi literature, was born.

In the year 1826, Raja Laxman Singh, a famous writer associated with the history of Hindi literature, was born. Till the age of 13, he continued to study Sanskrit and Urdu at home and in 1839, he entered Agra College to study English. On completion of college education, he was appointed as a translator in the office of the Lieutenant Governor of North-Western Province. He worked with great ability and was appointed as the Tehsildar of Etawah in 1855. He helped the British a lot in the revolt of 1857 and the British gave him the post of Deputy Collector as a reward.

The first two-way telephone conversation took place over a wire in the year 1876. The telephone arose from the creation and gradual improvements of the electrical telegraph. In 1804, Spanish polymath and scientist Francisco Salva Campillo created an electromechanical telegraph. Alexander Graham Bell and Thomas Watson were called upon to replay their first telephone conversation.



BRO Builds World's Highest Road at 19,400 ft

In an extraordinary engineering milestone, the Border Roads Organisation (BRO) has constructed the world's highest motorable road at a staggering 19,400 feet above sea level in Ladakh, breaking its own previous world record. Built under Project Himank, this road passes through Mig La Pass, surpassing the earlier record set at Umling La (19,024 ft) in 2021.

Key Points: -

- This accomplishment by BRO represents not just another world record but also a significant step in India's efforts to boost connectivity in one of the most extreme terrains on Earth.
- The newly built road is part of the Likaru-Mig La-Fukche alignment, offering both strategic military utility and tourism potential vate Limited
- Brigadier Vishal Srivastava, leading the operation, hoisted the National Flag and the BRO flag at the record site, symbolising national pride and technical mastery.

Location: The road passes over the Mig La Pass in Eastern Ladakh, India, a region close to the Line of Actual Control (LAC).


The Record: This new height of 19,400 ft surpasses the BRO's own previous Guinness World Record set at Umling La Pass (19,024 ft), also in Ladakh.

India-China to Resume Direct Flights by Late October /

In a significant step toward normalizing diplomatic and people-to-people exchanges, India and China have agreed to resume direct air services between designated points in both countries by late October 2025. This development marks a positive turn in bilateral relations that had witnessed prolonged tensions in recent years. The announcement was made by the Ministry of External Affairs (MEA) following technical-level discussions between the civil aviation authorities of the two nations.

When: Direct air services are set to resume by late October 2025, which coincides with the start of the winter aviation season schedule. The resumption is subject to the commercial decisions of the designated airlines and the fulfillment of all operational requirements.

Why the Suspension: Direct flights were initially halted in early 2020 due to the COVID-19 pandemic. They were not resumed afterwards due to heightened military and political tensions between the two countries, particularly following the Galwan Valley clash in June 2020.

Each Nobel Prize can be shared by up to three laureates. The first Nobel Prizes were awarded in 1901.




