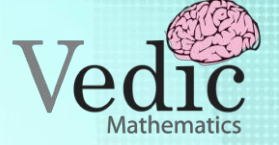

Major Discoveries and Observations

Planet in Formation Directly Imaged: For the first time, an international team of astronomers has directly imaged a planet actively being born. The gas giant, named WISPIT 2b, is forming around a young, Sun-like star inside a spectacular multi-ringed disk. The planet, estimated to be about 5 million years old, was captured using the European Southern Observatory's Very Large Telescope (ESO's VLT).

James Webb Space Telescope Reveals Butterfly Nebula Secrets: New data from the James Webb Space Telescope (JWST) on the Butterfly Nebula (NGC 6302) has provided insights into cosmic chemistry. Scientists were surprised to find certain molecules where they shouldn't exist, helping to solve long-standing puzzles about how carbon-based molecules form in space.

Asteroid Flyby: The asteroid 2025 PM2 made its closest approach to Earth, passing at a distance of about 2.31 million miles. While classified as a near-Earth object, experts confirmed it posed no threat. The event highlighted the importance of planetary monitoring and defense programs, with India's ISRO also planning missions to study asteroids in the future.

Spaceflight and Missions

SpaceX's Starship Test Flight: SpaceX successfully completed the 10th test flight of its Starship launch system. The flight achieved its objectives, including a first-of-its-kind payload deployment and a splashdown in the Indian

Ocean, marking a significant step forward for the program.

SpaceX Starlink Launch: A Falcon 9 rocket launched from Cape Canaveral, deploying 28 new Starlink satellites into orbit. This mission also marked the company's 400th successful landing of a Falcon 9 booster on a droneship at sea.

NOAA Satellite's "Photobomb": A NOAA satellite's coronagraph, a specialized telescope used to study the sun's faint outer atmosphere, captured a striking image of the Moon "photobombing" the Sun. The event was possible because the satellite orbits closer to Earth than previous coronagraphs, allowing it to occasionally see the Moon pass in front of its view.

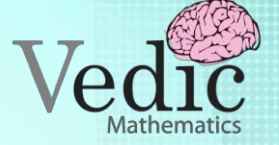
