That is an incredible feat for Kabak Yano! Summittin Aconcagua is often considered the ultimate "litmus test" for mountaineers aiming for Everest because of its brutal environmental conditions.

While it is technically a "trekking peak" (meaning you don't necessarily need ropes and ice axes for the standard route), the sheer physical toll of the "White Wind" (*Viento Blanco*) and the thin air makes it a massive achievement.

Elon Musk Becomes the First Person With \$800 Billion Wealth



This is a monumental shift in the global financial landscape. In February 2026, Elon Musk officially crossed the **\$800 billion** threshold, making him the wealthiest individual in recorded history by a staggering margin.

The primary driver of this \$84 billion single-day wealth surge was the **merger of SpaceX and xAI** (which includes the social media platform X). This restructuring didn't just move numbers around; it created a vertical powerhouse that Musk calls the "innovation engine for Earth and beyond."

The "SpaceX-xAI" Powerhouse

The merger, completed in early February 2026, valued the combined private entity at **\$1.25 trillion**. This move effectively consolidated Musk's AI research with his space infrastructure.

The Role of the Department of Defence (DoD)

RBI Clears Appointment of Former SBI MD as MD & CEO of Yes Bank



The Reserve Bank of India's (RBI) approval of **Vinay Muralidhar Tonse** as the MD and CEO of **Yes Bank** on February 3, 2026, marks the end of a high-stakes leadership transition. Tonse, a veteran with over 35 years of experience at the State Bank of India (SBI), is set to succeed **Prashant Kumar** in early April 2026.

This move is widely seen as a "steady-hand" strategy supported by Japan's **Sumitomo Mitsui**



Banking Corporation (SMBC), which now holds a nearly 25% stake in the lender.

Leadership Profile: Vinay Muralidhar Tonse

Tonse is recognized for his deep expertise in both retail operations and high-level corporate finance. His career trajectory at SBI provides a blueprint for the skills he brings to Yes Bank:

- Recent Role:** Served as Managing Director (Retail Business & Operations) at SBI until November 2025.
- Asset Management:** Previously led SBI Mutual Fund as its MD & CEO, overseeing significant growth in AUM.
- International Exposure:** Served as CEO of SBI's Osaka branch in Japan and worked in Singapore, providing him with a global perspective that aligns with SMBC's presence.

President's Rule in Tamil Nadu (1976)



This month marks the **50th anniversary** of one of the most significant and controversial chapters in Indian federalism. On **January 31, 1976** (effective through February), the DMK government led by **M. Karunanidhi** was dismissed by the Central Government, marking the first time President's Rule was imposed in Tamil Nadu.

This move was a defining moment of the **Emergency era** (1975–1977) and permanently

The Context of the Dismissal

While the official reason cited was "maladministration and corruption," the dismissal was widely viewed as a political move by Prime Minister Indira Gandhi's government. The DMK had been one of the few state governments openly resisting the Emergency.

Why It Happened: 3 Primary Drivers

The dismissal was the culmination of months of friction between Madras (now Chennai) and New Delhi:

- Defiance of the Emergency:** Karunanidhi famously organized a massive protest at Marina Beach against the Emergency, passing a resolution in the Assembly to "save democracy."
- Protection of Dissidents:** Tamil Nadu had become a safe haven for national leaders fleeing arrest under MISA (Maintenance of Internal Security Act).

- The Sarkaria Commission:** Following the dismissal, the Centre appointed Justice R.S. Sarkaria to investigate allegations of corruption against Karunanidhi and his cabinet, which became a long-running political saga.

Consequences and Impact

The imposition of President's Rule led to the arrest of over **25,000 DMK cadres** and leaders, including future Chief Minister **M.K. Stalin**, who was detained under MISA.

Political Shift: This period saw the rise of the **AIADMK** under M.G. Ramachandran (MGR). When elections finally took place in 1977 after the Emergency was lifted, MGR led his party to a historic victory, beginning an era where the AIADMK and DMK would alternate power for decades.

The Constitutional Legacy

The 1976 dismissal remains a textbook example in Indian law schools of the potential for **Article 356** to be used for political ends—a practice that was eventually curtailed by the landmark **S.R. Bommai v. Union of India (1994)** judgment by the Supreme Court.



Why Gandhi Called It Off

Gandhi described the event as a "Himalayan Miscalculation." His reasoning was two-fold:

- Moral Grounds:** He believed the Indian people were not yet fully trained in the discipline of non-violence.
