



Microsoft's US\$17.5 Billion Investment in India to Drive AI Diffusion at Population Scale



India is entering a defining phase in its technology journey, rapidly moving from digital public infrastructure to AI public infrastructure. Strengthening this transition, Microsoft has announced a record US\$17.5 billion investment in India, to be deployed over 2026–2029. This represents the company's largest investment in Asia and builds on the US\$3 billion committed earlier in 2025, which will be fully utilized by the end of 2026.





Lithuania Declares State of Emergency **Over Balloon Incursions From Belarus**



In a moment of cultural pride for India, Deepavali, the iconic festival of lights, has been officially inscribed on the UNESCO Representative List of the Intangible Cultural Heritage of Humanity 2025. The inclusion affirms the festival's deep cultural, spiritual, and social significance, celebrated by millions across India and global diaspora. UNESCO's recognition also brings broader visibility to India's living cultural traditions, reaffirming their value in a rapidly globalizing world.

In a major escalation of regional tensions, Lithuania has declared a state emergency on December 2025, citing repeated airspace violations by cigaretteladen balloons launched from Belarus. These incursions, described as a form of hybrid attack, have endangered aviation safety, disrupted public life, and

Tamil Nadu issued the Alienation of Immovable Property of the Religious Institutions Rules, 2025 for temple land sale, exchange, lease, and mortgage. Sale value is set at 225% in urban areas, 275% within 30 km, 325% within 30–50 km, and 425% beyond 50 km from urban areas.



HISTORICAL AND TECHNICAL EVENTS OF 5[™] DECEMBER 2025

1232: Iltutmish captures Gwalior.



In 1231, Iltutmish laid siege to the city, and captured it on 12 December 1232 after an 11-month struggle.

After Mangal Dev fled, Iltutmish left the fort under one of his officers Majdul Mulk Ziauddin.

In 1233–1234, Iltutmish placed Gwalior under Malik Nusratuddin Taisi, who was also given the iqta of Sultankot and Bayana and put in charge of the military garrisons Kannauj, Mehar and at Mahaban.

1921: Prince of Wales inaugurated Banaras Hindu University.



From 1921, the entire university education was shifted from 'Kamacha College' to new buildings. It was inaugurated by the 'Prince of Wales' in December 1921. Pandit Madan Mohan Malviya founded Banaras Hindu University 108 years ago in 1916. At that time, it had only one college - Central Hindu College and today this university is spread over an area of 15 square kilometers.

1974: Malta becomes a republic



In December 1974, the constitution was amended and Malta became a republic the Commonwealth. with within executive power vested in the Maltese president. The president appoints the leader of the majority party in the House of Representatives as prime minister.

2002: EU expansion



In 2002, the EU approved agreements to include Cyprus, the Czech Republic, Estonia, Hungary, Latvia, Lithuania, Poland, Slovakia, and Slovenia. This was one of the largest expansions of the union, which promoted political and economic integration in Europe.



2006: Vietnam joins the World Trade **Organization**



In 2006, a notification was issued to admit Vietnam into the World Trade Organization (WTO) as the 150th member. This increased Vietnam's participation in global trade and boosted economic growth.

Established on January 1, 1995, the WTO is the only international body governing global trade rules. With 165 member countries accounting for more than 90% of global trade, its main mission is to promote fair and free trade between countries, reduce trade barriers and support the economic development of members.






