Union Minister Sarbananda Sonowal Unveils India's First Zero-Emission **Electric Tug Project**



India has taken an important step toward clean and modern port operations. Union Minister Sarbananda Sonowal virtually launched the steel-cutting ceremony for the country's first fully electric green tug. This project is part of India's effort to make its ports cleaner, greener and ready for the future. The new tug is being built for the Deendayal Port Authority (DPA) in Kandla under the Green Tug Transition Programme (GTTP).



RBI Issues Master Directions Allowing Residents and Non-Residents to Trade in **Rupee Interest-Rate Derivatives**



In a major regulatory move aimed at deepening India's financial markets, the Reserve Bank of India (RBI) released master directions permitting residents and non-residents to conduct rupee-denominated transactions in interest-rate derivatives (IRD). These directions follow the draft guidelines issued in Iune and provide comprehensive framework on participation, permissible instruments, position limits, reporting requirements, and risk disclosures.

ASI Digital Epigraphy Project



Division of The Epigraphy Archaeological Survey of India (ASI) has begun digitising all Tamil estampages by scanning them and uploading them to a dedicated online repository for easy holds 24,806 Tamil access. ASI estampages, and scanning has been completed for 13,740, covering nearly 25,000 Tamil inscriptions. The division is also digitising estampages of inscriptions in other Indian languages as well as Arabic and Persian. The work is part of Bharat Shared Repository Inscriptions (Bharat SHRI).
