



1398: Mongol emperor Timurlang captured Delhi.



Timur attacked India in 1398 AD during the reign of Nasiruddin Mahmud, the last ruler of the Tughlaq dynasty. This attack proved fatal for the Tughlaq dynasty. Due to which the Tughlaq dynasty was destroyed.

Timur attacked India in 1398 AD. He crossed the Indus and captured Multan and easily conquered Delhi.



1803: East India Company captured Odisha.



The Marathas ruled over entire Odisha for a few years and finally handed over Angul and the entire region of Odisha to the British East India Company in 1803 AD and thus began the British era in the history of Angul. During the British rule, the rulers mainly followed instructions of the Company in ruling the state.

When Odisha was formed, there were only 5 districts. The state was established on 1 April 1936. After this, many other districts were created over the years. Odisha has an area of more than 154468 square kilometers.






1777: France recognizes American independence.



On December, 1777, the French Foreign Minister, Charles Gravier, Count of Vergennes, officially acknowledged the United States as an independent nation. The leaders of the American Revolution were colonial separatist leaders who originally sought greater autonomy as British subjects, but later gathered to support the Revolutionary War, which ended British colonial rule over the colonies.



1907: Ugyen Wangchuck becomes the first king of Bhutan.



Ugyen Wangchuck established the monarchy in 1907, although he had been more or less the de facto ruler for more than a decade. On December 1907, Ugyen Wangchuck was elected unanimously by the representatives of the people, officials and clergy and enthroned as the first hereditary king of Bhutan at Punakha Dzong.




