GeM's Womaniya Initiative Completes 7 Years Empowering Women

By integrating gender-responsive policies into a digital marketplace, the Government e-Marketplace (GeM) has essentially created a "fast track" for women-led businesses that previously struggled with the complexities of public tenders.

### The Impact of the "Womaniya" Initiative

The success of this initiative can be attributed to three core pillars that have restructured the procurement landscape for women:

- **Removal of Intermediaries:** By providing a direct digital interface, the platform eliminates "middlemen" who often diluted the profits of small-scale women artisans and SHGs.
- **Capacity Building:** GeM doesn't just provide a storefront; it offers training and toolkits to help women navigate the digital registration and bidding process.

- Market Visibility:** It brings hyper-local products—from tribal handicrafts to specialized services—to the attention of national-level government departments and Public Sector Undertakings (PSUs).

- Digital Literacy:** Joining the platform necessitates a level of digital proficiency that translates to other areas of business and life.

India Post Delivers First ONDC Order, Enters Digital Logistics Era



This development is a game-changer for "Bharat" (rural and semi-urban India). By turning its centuries-old network into a high-tech logistics backbone for the **Open Network for Digital Commerce (ONDC)**, India Post is solving the "last-mile" problem that has historically kept small rural sellers away from the national market.

The official delivery took place on **January 15, 2026**, marking the formal entry of the Department of Posts as a **Logistics Service Provider (LSP)** on the network.

### How the Integration Works: The "Click & Book" Model

The Department of Posts has moved beyond simple mail to a technology-driven logistics system. Under this new model:

- **Digital Booking:** Sellers on any ONDC-enabled app can now choose "India Post" as their delivery partner.

Yemen PM Resigns, Foreign Minister Appointed as New Prime Minister



This transition in Yemen represents more than just a change in personnel; it is a strategic restructuring of the **Presidential Leadership Council (PLC)** to consolidate control amidst a volatile power struggle between regional heavyweights.

The resignation of Salem bin Breik and the appointment of Shaya Mohsen Zindani on

**January 15, 2026**, follows a dramatic military and political escalation in southern Yemen.

### The Leadership Shift

The PLC, headed by **Rashad al-Alimi**, officially approved the resignation of bin Breik during a meeting in Riyadh. The transition moved swiftly to ensure that the internationally recognized government maintained a unified front.

- **Outgoing PM:** Salem bin Breik (Now appointed as a senior financial and economic advisor to the PLC head).
- **Incoming PM:** Shaya Mohsen Zindani (Formerly the Foreign Minister and a career diplomat known for his close ties to al-Alimi).
- **The Mandate:** Zindani has been tasked with forming a new cabinet that "keeps pace with the transformations" recently experienced in the country.

### Context: The "Southern Crisis"

The catalyst for this reshuffle was a major rupture within the anti-Houthi coalition in late December 2025 and early January 2026:

1. **STC Offensive:** Forces loyal to the **Southern Transitional Council (STC)**, backed by the UAE, seized key southern provinces like Hadramaut and Al-Mahrah, threatening Saudi border security and oil operations.
2. **Saudi Response:** Saudi Arabia conducted heavy airstrikes on STC positions and massed troops to roll back the advance. By early January, STC control collapsed, and

Saudi-backed forces retook the port city of Aden.

3. **The Purge:** Following the military victory, the PLC stripped STC leader **Aidarous al-Zubaidi** of his council membership on charges of high treason. Other UAE-aligned ministers were also dismissed or referred for investigation.

### Why Zindani?

Shaya Mohsen Zindani's appointment is viewed as a move to **centralize sovereign decision-making** under Saudi-backed leadership. As a veteran diplomat from the al-Dhale' governorate, he is expected to:

- **Stabilize the Economy:** Address the collapse of the Yemeni riyal and the paralysis in state services (like the electricity crisis in Aden).
- **Navigate Geopolitics:** Use his foreign policy background to manage the strained relations between Saudi Arabia and the UAE regarding Yemen's future.
- **Restore Institutions:** Integrate various security and military factions under the central authority of the Defense and Interior Ministries.

### Regional Implications

This change marks a significant setback for southern separatist ambitions and signals Saudi Arabia's intent to lead a more unified Yemeni government. However, with the Houthi still

controlling the north (including Sanaa) and internal tensions remaining high, Zindani faces a daunting task in providing a "model of a functional state."

## APPOINTMENT

### Centre Appoints Rakesh Aggarwal as New Director General of NIA



The Union Government has significantly restructured the leadership of India's top internal security and border-guarding agencies. These appointments, approved by the Appointments Committee of the Cabinet (ACC) on January 14, 2026, emphasize institutional continuity and operational experience at a time of heightened regional security concerns.

### Key Institutional Changes

#### 1. National Investigation Agency (NIA)

**Rakesh Aggarwal** takes over as the regular Director General after serving as the Special DG and holding the interim charge following the repatriation of the previous chief, Sadanand Vasant Date, to Maharashtra.

- Focus:** His tenure is expected to focus on the NIA's evolving role in dismantling terror-funding networks and investigating global extremist links within India.

#### 2. Border Security Force (BSF)

## December 2025: A Month of Pure Dominance

Laura Wolvaardt's crowning as the **ICC Women's Player of the Month for December 2025** is a fitting tribute to one of the most dominant individual months in recent cricket history.



Transitioning to the longer format, she maintained her relentless form to lead South Africa to a clinical whitewash.

- **2nd ODI (Gqeberha):** Smashed 124 off 111 balls (19 boundaries), anchoring a massive team total of 375.
- **3rd ODI (Johannesburg):** Followed up with an unbeaten 100 off 93 balls\* to comfortably chase down Ireland's target.
- **Overall ODI Stats:** 255 runs at an average of 127.50.

### RBI Mandates Auto Transfer of Unresolved Complaints to Internal Ombudsman



The Reserve Bank of India (RBI) has introduced a more robust customer protection framework by notifying the **Internal Ombudsman (IO) Directions, 2026** on January 14, 2026. This overhaul moves away from discretionary grievance handling and mandates a strictly

automated, "check-and-balance" system within financial institutions.

The primary goal is to ensure that no customer complaint is rejected without being vetted by an independent, high-level authority—the Internal Ombudsman—before the bank or NBFC sends its final response.

### Key Changes in the 2026 Directions

The new framework introduces several structural shifts to make grievance redressal faster and more transparent:

- Mandatory Auto-Escalation:** Regulated Entities (REs) must now use a fully automated Complaint Management System (CMS). Any complaint categorized as "Partially Resolved" or "Wholly Rejected" must be automatically transferred to the Internal Ombudsman for review.
- Independent Oversight:** The IO cannot be a current employee of the bank or its subsidiary. They must be a retired or serving officer (rank of General Manager or equivalent) from another financial entity or regulator, ensuring an unbiased "outsider's" perspective.
- Strict Timelines:** \* **Internal Review:** The IO must be given at least **10 days** for cases involving standard RBI/NPCI guidelines and **20 days** for other complaints.
  - Final Decision:** The bank must communicate the final decision to the customer within **30 days** of receiving the original complaint.
- Limited Overruling:** A bank's management can only overrule an IO's recommendation

with the explicit approval of a **Whole-time Director or Executive Director**. These cases must then be reported to the Board's Customer Service Committee.

### Comparison of Grievance Redressal (Old vs. New)

### Who is Covered?

The 2026 directions apply to a wide range of entities that meet specific criteria as of March 31, 2025:

- **Commercial Banks:** All banks with 10 or more outlets.

- **NBFCs:** Deposit-taking NBFCs with 10+ branches and Non-deposit-taking NBFCs with an asset size of ₹5,000 crore and above.
- **Others:** Payments Banks, Small Finance Banks, Credit Information Companies (CICs), and non-bank PPI (Prepaid Instrument) issuers.

**Note:** The Reserve Bank - Integrated Ombudsman Scheme (RB-IOS), 2026 was also announced, which will go live on July 1, 2026. This acts as the secondary level of appeal if a customer is still unsatisfied after the Internal Ombudsman's review.

### Why This Matters for Customers

This "front-loads" accountability. Instead of a customer having to figure out how to approach the RBI Ombudsman, the bank is now legally forced to involve its own internal judge (the IO) to double-check any decision that doesn't fully favor the customer. It reduces the "arbitrary rejection" of legitimate claims.

The clearing of **50 lakh metric tonnes** of legacy waste at the Perungudi dumpsite marks a major environmental victory for Chennai. This effort, equivalent to removing a "mountain of garbage" that stood for five decades, is a critical step in restoring the ecologically sensitive **Pallikaranai marshland**, a designated Ramsar site.

## The Scale of the Transformation

The project is being executed in phases, with the Greater Chennai Corporation (GCC) aiming for a "zero-landfill" future for the city.

- Total Legacy Waste:** 90 lakh metric tonnes.
- Current Progress:** 50 lakh metric tonnes (approx. 55%) cleared as of January 2026.
- Target Completion:** February 2027.
- Land Reclaimed:** Approximately 100 acres have already been recovered and are being mapped for restoration or handover to the Forest Department.

## How Biomining Works: From Trash to Treasure

The process, managed by **Blue Planet Environmental Solutions**, does not just move waste; it scientifically segregates and repurposes it.

## Restoring the Pallikaranai Marshland

The Perungudi site sits directly adjacent to the Pallikaranai marshland—one of the last natural wetlands in South India. For years, the dumpsite was a source of toxic leachate (polluted liquid) and frequent methane fires.

- Pollution Mitigation:** Biomining neutralizes the soil and prevents further toxic runoff into the wetland.
- Flood Resilience:** Reclaiming the land allows the marshland to return to its natural function as a giant sponge, significantly reducing flood risks for neighborhoods like Velachery and Thoraipakkam.
- Biodiversity Recovery:** Once the waste is cleared, the land is expected to be integrated back into the marshland ecosystem to support over 115 bird species and 46 fish species.

**Did You Know?** The Refuse-Derived Fuel (RDF) generated from the plastic waste at Perungudi has already helped avert over **55,000 tonnes of \$CO<sub>2</sub> emissions**, which is roughly equal to taking 12,000 cars off the road for a year.

## What's Next?

While Perungudi is nearing completion, the GCC has already begun scaling this success to the **Kodungaiyur** dumpyard in North Chennai, which is nearly three times larger. The goal is to transform Chennai into a model for circular waste management in India.

## FACTS ABOUT BHARAT

Kohima is indeed a fascinating blend of history and heritage. While the name "Kohima" is what the world uses today, your mention of "Kewhira" touches on the authentic identity of the land.

### The Origin of the Name

The name is deeply rooted in the Angami Naga culture and geography:

- **Kewhima / Kewhira:** The original name comes from the Kewhi flower, a wild flower (often associated with species like *Rhododendron* or *Lilium maclineae*) that once grew in abundance across the ridges.
- **The Translation:** In the local *Tenyidie* dialect, *Kewhima* translates to "the land where the Kewhi flower grows." \* **The British Influence:** When British administrators established their headquarters there in 1878, they found "Kewhira" difficult to pronounce. Over time, it was anglicized to "Kohima," which became the official administrative name.

### The Soul of the Angami Naga Tribe

Kohima is the ancestral home of the Angami Naga, one of the 16 major tribes of Nagaland. They are renowned for:

- **Terrace Cultivation:** Unlike many other tribes that practiced *Jhum* (slash-and-burn) agriculture, the Angamis are masters of stone-walled terrace farming, which carves the hillsides into beautiful green "steps."

- **Sekrenyi Festival:** Celebrated in February, this is their "Festival of Purification," where tribal members perform rituals to sanctify their bodies and souls for the coming year.
- **Architecture:** The city is unique because it still houses Kohima Village (Kewhira), often called the second-largest village in Asia, right within the urban limits. It features traditional large wooden gates (*Kharu*) and houses decorated with buffalo horns.

### A City of "Serpentine" Beauty

As you noted, the city's layout follows the natural contours of the mountain ranges. This geography played a pivotal role in history:

- **Battle of Kohima (1944):** Often called the "Stalingrad of the East," the ridges and tennis courts of Kohima were the site of a fierce WWII battle where Allied forces stopped the Japanese advance into India.
- **The War Cemetery:** Today, it stands on the Garrison Hill ridge, famous for the inscription: *"When you go home, tell them of us and say, for your tomorrow, we gave our today."*
