Overall LFPR Show Upward Momentum as Unemployment Falls to New Low In November 2025



Labour Force Participation Rate (LFPR)

The LFPR measures the percentage of the population that is either working or actively seeking work.³

- **Overall LFPR:** Rose to **55.8%**, the highest level since the revamped monthly reporting began in April 2025.⁴
- **Rural vs. Urban:** The growth was primarily driven by rural areas, where LFPR climbed to **58.6%** (up from 57.8% in October). Urban areas saw a marginal dip to **50.4%**.⁵
- **Female Participation:** A standout highlight was the surge in rural female LFPR, which jumped to **39.7%**.⁶ This contributed to an overall female LFPR of **35.1%**, up from 32.0% in June.⁷

2. Worker Population Ratio (WPR)

The WPR represents the percentage of the total population that is employed.

- Employment Growth: The overall WPR improved to 53.2% in November, up from 52.5% in the previous month.
- Rural Dynamics: Rural WPR reached supported by seasonal agricultural activities like Rabi sowing.
- **Female Employment:** The rural female WPR saw a notable increase to 38.4%. pushing the overall female employment ratio to 33.4%.

3. Unemployment Rate (UR)

The unemployment rate fell to its lowest point in the 2025 reporting cycle. 12

- New Low: The overall UR declined to 4.7% (down from 5.2% in October).¹³
- Sectoral Breakdown: * Rural UR: Dropped to a new low of 3.9%.14
 - **Urban UR:** Eased to **6.5%**, matching its previous low from April.15
- Gender Trends: Both genders improvements.¹⁶ The male UR fell to **4.6%**, while the female UR dropped to 4.8% (down from 5.4% in October).¹⁷

Bharat Taxi to Roll Out in January 2026



- The Cooperative Business Unlike private giants that operate on highcommission structures. Bharat Taxi democratically controlled.
- **Zero-Commission** Policy: **Drivers** expected to retain 80% to 100% of the fare. Only a minimal fraction is diverted to a common pool to cover operational and app maintenance costs.
- **Driver Ownership:** Registered drivers are stakeholders in the cooperative. This means they participate in decision-making and share in any surplus generated by the platform.
- **Backing:** The cooperative is chaired by **Jayen** Mehta (MD of Amul) and is backed by major cooperative bodies including IFFCO. NABARD, and NAFED.

- **2. Key Features for Passengers:** For the commuter, Bharat Taxi aims to solve the most common pain points of existing ride-hailing apps:
 - No Surge Pricing: Fares are fixed and predictable. Unlike dynamic algorithms, prices do not spike during peak hours, rain, or festive rushes.
 - Transparent Fares: The minimum fare is set at ₹30 for up to 4 km, followed by approximately ₹23/km for mid-distances (4–12 km) and ₹18/km for longer trips.
 - Multi-Modal Service: The app offers a comprehensive range of transport, including:
 - Autos & Bike Taxis for short distances.
 - Hatchbacks, Sedans, and XL Cabs for city and outstation travel.
 - Digital Integration: The platform is integrated with government services like DigiLocker and UMANG for seamless identity verification and safety.
- 3. Launch & Scalability

The project has already demonstrated significant momentum during its trial phase:

- Pilot Launch: Beta testing began in December 2025 across New Delhi and the Saurashtra region of Gujarat (including Rajkot).
- Official Launch: Scheduled for January 1, 2026, starting in the National Capital.
- Network Size: Within just 10 days of registration, the cooperative onboarded

- over **51,000 drivers**. As of late December, registrations have surpassed **100,000** nationwide, with 56,000 in Delhi alone.
- **Future Expansion:** The service plans to expand to over **20 cities** shortly after the initial rollout.

India and Saudi Arabia Sign Visa Waiver Agreement to Facilitate Official Travel



- 1. Scope and Eligibility: The waiver is highly specific and does not apply to the general public. It is tailored to streamline the movement of those managing the strategic relationship between the two nations.
 - Eligible Passports: Holders of Diplomatic, Special, and Official passports.
 - Stay Duration: Allows for visa-free entry for short stays (typically up to 90 days within a 180-day period).
 - **Exclusions:** The agreement does not apply to:
 - Ordinary passport holders (tourists, workers, or business travellers).
 - Long-term stays, employment, residency.
- **2. Strategic Objectives:** The timing of this agreement is significant, coming amid a surge in bilateral cooperation across energy, defines, and technology.


- Reducing Red Tape: Previously, official delegations often faced delays of up to four weeks for visa processing. The waiver allows joint working groups to meet on short notice.
- Accelerating "Vision 2030" Projects: Saudi Arabia's massive infrastructure and energy projects (under Vision 2030) and India's National Logistics Policy require constant official oversight and technical consultations.
- Strengthening Parliamentary Ties: The deal follows the announcement of an India-Saudi Arabia Parliamentary Friendship Group, aimed at fostering deeper legislative cooperation.

3. Implementation and Future Outlook

While the agreement was signed in mid-December, a brief transition period is expected for ground-level implementation.

- **System Integration:** Border agencies in both countries have approximately 30 days to update their e-immigration systems to recognize the new exemption.
- Note Verbale: Even with the waiver, travellers are generally required to carry a note verbale (a formal diplomatic note) from their respective foreign ministries to confirm the official nature of their visit.
- **Potential Expansion:** Mobility analysts suggest that such diplomatic waivers often serve as "confidence-building measures" that could eventually lead to eased visa rules for business professionals and investors.

The championship was inaugurated and the winners were felicitated by the J&K Sports Minister, **Satish Sharma**.



Farm Sector status in Tamil Nadu 2025



Based on the latest data from the **RBI Handbook** of Statistics on Indian States and recent economic reports, agriculture has emerged as the primary drag on Tamil Nadu's otherwise booming economy. Despite reaching a record real GSDP growth of 9.69% in 2024-25 (the highest in India), the state's farm sector has faced a significant downturn.

Agricultural Performance (2023–25)

The agriculture and allied activities sector recorded negative growth in the last two fiscal years.

- **2024–25 Growth: -0.09%** (First negative growth in 8 years).
- Key Driver of Decline: The crop segment specifically saw a sharp contraction of -**5.93%**, which offset the resilience shown by the livestock and fisheries sub-sectors.

- Food Grain Production: Output fluctuated between 107 and 120 lakh tonnes.
 - Peak: 119.98 lakh tonnes (2021-22).
 - **Low Point:** 107 lakh tonnes (2023–24).



Sectoral Shift in the Economy

agriculture struggled, While maintained its position as India's second-largest economy due to the dominance of industry and services.

Sector	Contribution to GSVA (%)	Performance Highlight (2024–25)
Tertiary (Services)	~53-54%	Grew by 12.7% ; driven by real estate and financial services.
Secondary (Industry)	~34–37%	Grew by 9% ; Tamil Nadu ranks 1st in India in number of factories.
Primary (Agriculture)	~10-13%	Growth was nearly flat (0.15%) or negative (-0.09%) depending on real vs. nominal terms.

Why is the Farm Sector Declining?

Experts and state documents point to several structural and environmental bottlenecks:

Climatic Stress: Erratic monsoons. unseasonal heavy rains in early 2025, and damage from Cyclone Fengal (Dec 2024) affected over 9 lakh acres.

- **Crop Imbalance:** Production is heavily skewed toward paddy (rice), which accounts for 64% of food grains.
- **Dwindling Commercial Crops:** Sugarcane production has plummeted from 411 lakh tonnes (2006-07) to roughly 133.5 lakh tonnes today. Cotton and oilseeds have seen similar "southward" trends.
- **Structural Issues:** Shrinking landholdings (average 0.75 hectares), aging farming population, and lack of procurement facilities for crops other than rice.

The Path Forward

To revitalize the sector, the **Tamil Nadu State** Planning Commission and agricultural experts recommend:

- 1. **Horticulture Focus:** Shifting attention to high-value fruit and vegetable crops, especially in rain-fed areas.
- 2. Climate Resilience: Promoting "Shri Anna" (millets) and climate-resilient varieties.
 - 3. **Policy Revisions:** Updating the state's food processing policy to ensure better price realization for non-paddy crops.





Technical Historical and Events of 22nd December 2025

1921: Vishwa-Bharati University inaugurated.



Inaugurated on December 23, 1921, Visva-Bharati was the realization of Rabindranath Tagore's vision to create a global center where "the whole world makes its home in a single nest" (Yatra visvam bhavati ekanidam).

The university was founded as a protest against the colonial education system of the time, which Tagore felt was restrictive and disconnected from nature and local culture.

The Vision of "Meeting of Races"

The core philosophy behind the inauguration was to build a bridge between the East and the West. Tagore believed that the "meeting of races" should not be based on political or economic dominance, but on intellectual and spiritual fellowship.

Global Fellowship: Tagore invited scholars from across the globe to live and work in the "desert of Bolpur." Early collaborators included the French scholar Sylvain Lévi, the Italian Giuseppe Tucci, and the English missionary C.F. Andrews.

- A "New Indian Personality": The goal was to develop a generation that was neither strictly Eastern nor Western, but a "reconciler both," capable of of appreciating the diverse currents of Indian tradition alongside Western liberal ideals.
- **Cultural Exchange:** Visva-Bharati was established as a center for the study of varied religious and cultural currents, including Vedic, Buddhist, Islamic, Sikh, and Christian traditions, as well as the fine arts and music.

Structure and Key Milestones

Key Date	Milestone
1901	Tagore founded a small school for children at Shantiniketan (<i>Brahmacharyasrama</i>).
Dec 23, 1921	Official Inauguration of Visva-Bharati as an international university.
May 1922	Visva-Bharati Society was formally registered.
1951	Declared a Central University and an Institution of National Importance.
2023	Recognized by UNESCO as the world's first "Living Heritage University."

A Unique Educational Model

Visva-Bharati is famous for its open-air classrooms, where lessons are held under the shade of trees. Tagore believed that nature was the most fertile ground for a "free and fearless" mind.

1922: BBC radio begins daily news broadcasts.



The formation of the British Broadcasting Company in 1922 marked the birth of public service broadcasting. It transitioned from a commercial venture by radio manufacturers into the global institution we recognize today.

The Birth of the BBC (1922)

- Foundation: The company was formed on October 18, 1922, by a consortium of leading wireless manufacturers, including Marconi, General Electric, and British Thomson-Houston. Their primary goal was encourage the sale of radio sets by providing consistent content.
- First **Broadcasts:** Daily broadcasting officially began on **November 14, 1922**, from the **2LO station** located at Marconi House in the Strand, London. The first program was a news bulletin supplied by the Press Association.
- The First Leader: In December 1922, John Reith was appointed General Manager. Despite having no background broadcasting, his vision of "inform, educate, and entertain" became the enduring blueprint for the BBC.

Key Milestones of the Early Era

Year	Milestone ate Limited
1922	October 18: British Broadcasting Company Ltd is formed.
1922	November 14: First 2LO broadcast from London; 5IT (Birmingham) and 2ZY (Manchester) follow within days.
1923	The Radio Times is launched to list program schedules.
1927	The private <i>Company</i> is dissolved and replaced by the British Broadcasting Corporation , established by Royal Charter.



John Reith (later Lord Reith) was instrumental in transforming the BBC from a commercial entity into a public corporation. He famously advocated for impartiality and cultural elevation, believing that the BBC should provide the best of human knowledge and art to everyone, regardless of their social standing.

"The BBC's mission is to enrich people's lives with programs that inform, educate and entertain." — The Reithian Principle

Did You Know?

- The First News: The very first news broadcast in 1922 had to be read twice once at normal speed and once slowly—so that listeners could take notes if they wished.
- Strict Dress Codes: In the early days, radio announcers were required to wear full evening dress (tuxedos), even though the audience couldn't see them, to maintain the "seriousness" of the medium.



December 22, 2025, marks the eve of Kisan Diwas


Today, December 22, 2025, marks the eve of Kisan Diwas (National Farmers' Day), which will be celebrated tomorrow across India to honor the legacy of Chaudhary Charan Singh.

Born on December 23, 1902, in Noorpur (Hapur), Uttar Pradesh, Chaudhary Charan Singh is remembered as the "Champion of India's Peasants." His life and policies were deeply rooted in the rural Indian landscape, earning him a unique place in the nation's history.

The "Messiah" of Farmers

Chaudhary Charan Singh's political identity was inseparable from the welfare of the agrarian



community. He famously believed that the "path to India's prosperity passes through the villages."

- Zamindari Abolition: As the Revenue Minister of Uttar Pradesh, he was the chief architect of the UP Zamindari Abolition and Land Reforms Act, 1952. This landmark legislation ended the feudal system in the state, giving land ownership rights to millions of actual tillers.
- **Land Ceiling Acts:** He pushed for laws that limited the size of landholdings to ensure equitable distribution among small and marginal farmers.
- **Protection from Exploitation:** He introduced the Debt Redemption Bill (1939) and the


