Second Range wide Dolphin Survey Launched Under Project Dolphin



In January 2026, the Union Ministry of Environment, Forest and Climate Change officially launched the **Second Range-wide Dolphin Survey** from Bijnor, Uttar Pradesh. This scientific initiative marks a significant escalation in India's efforts to protect its "National Aquatic Animal" and other vital cetacean species under the umbrella of **Project Dolphin**.

Key Highlights of the 2026 Survey

This nationwide exercise is more than just a head count; it is a comprehensive ecological audit of India's riverine and estuarine health.

- Expanded Scope:** Unlike the first survey, this round has expanded its spatial coverage to include the Irrawaddy Dolphin in the Sundarbans and Odisha.
- Target Species:** The survey primarily focuses on three species:
 - Gangetic River Dolphin** (India's National Aquatic Animal)





- 2. **Indus River Dolphin** (found in the Beas River)
- 3. **Irrawaddy Dolphin** (found in estuarine and coastal waters)
- **Phased Approach:** * **Phase I:** Focuses on the main stem of the Ganga (Bijnor to Ganga Sagar) and the Indus River system.
 - **Phase II:** Will extend to the Brahmaputra, Ganga tributaries, the Sundarbans, and Odisha.
- **Advanced Technology:** Researchers are utilizing **hydrophones** for underwater acoustic monitoring, allowing them to detect dolphins that may not surface frequently.

Feature	Objective
Scientific Monitoring	Using satellite tagging (first achieved in Assam in late 2024) to track migratory patterns.
Community Engagement	Involving local fishermen to reduce "by-catch" (accidental entanglement in nets).
Habitat Protection	Addressing threats from low water levels, pollution, and dredging in protected areas like the Vikramshila Sanctuary.

The Success of the First Survey (2021-2023)

The data from the first-ever nationwide survey (released in March 2025) provided the baseline for the current effort:

- **Total Count:** ~6,327 riverine dolphins were recorded across India.
- **Leading States:** Uttar Pradesh (2,397) and Bihar (2,220) emerged as the primary strongholds for the Gangetic Dolphin.
- **Critical Habitat:** The findings highlighted the importance of the Gangetic basin for long-term species survival.

Strategic Goals of Project Dolphin

Project Dolphin is a 10-year initiative launched in 2020. It treats dolphins as **indicator species**—meaning their population health directly reflects the pollution levels and water quality of India's rivers.

Note: The Gangetic River Dolphin is functionally blind and relies almost entirely on echolocation (emitting ultrasonic sounds) to navigate and hunt in murky river waters.

Responsible Nations Index Launched to Measure Ethical and Inclusive Governance



In January 2026, former President Ram Nath Kovind inaugurated the **Responsible Nations Index (RNI)** at the Dr. Ambedkar International Centre in New Delhi. This pioneering framework, developed by the **World Intellectual Foundation (WIF)**, represents a paradigm shift in how global success is measured—moving away from traditional GDP or military-centric

rankings toward a focus on ethical accountability and humanitarian impact.

Core Dimensions of the RNI

The index evaluates **154 countries** through a rigorous framework consisting of **three core pillars**, 7 dimensions, and 58 specific indicators:

- Internal Responsibility:** Focuses on the dignity, justice, and well-being of a nation's own citizens, including social equity and governance quality.
- Environmental Responsibility:** Measures a country's commitment to climate action, ecological stewardship, and the sustainable use of natural resources.
- External Responsibility:** Assesses a nation's contribution to global peace, multilateral cooperation, and international stability.

Rank	Country	Key Highlight
16	India	Highest-ranked Asian nation; placed ahead of the UK, US (66th), and China (68th).

Strategic Significance

The RNI was developed over three years in collaboration with Jawaharlal Nehru University (JNU) and IIM Mumbai. Its launch signals India's intent to become a "norm entrepreneur" by redefining what it means to be a global leader.

Museveni Secures Seventh Term in Uganda As President



In January 2026, Uganda's long-serving leader, Yoweri Museveni, was officially declared the winner of a high-stakes presidential election, securing his **seventh term** in office. The results, however, have plunged the nation into a fresh wave of political uncertainty as the opposition decries the process as a "sham."

Election Results Breakdown

The Uganda Electoral Commission announced the final tallies on January 17, 2026:

Controversy and Irregularities

The 2026 election followed a pattern of tension similar to the 2021 polls, with several factors leading to international and domestic criticism:

- Internet Blackout:** For the second consecutive election, the government imposed a **nationwide internet shutdown** starting two days before the vote (January 13). While authorities cited "national security" and "preventing misinformation," rights groups like Amnesty International labeled it a "digital darkness" designed to mask fraud.
- Harassment of the Opposition:** Bobi Wine alleged that his home was raided by security forces on the eve of the results, forcing him into hiding. He has since rejected the results, citing "massive ballot stuffing" and the kidnapping of polling agents.
- Voter Suppression:** Reports emerged of **biometric voter verification kits** failing in opposition strongholds like Kampala, leading to delays and a shift to manual voting, which the opposition claims allowed for easier manipulation.

Global Scrutiny

International observers, including a joint mission from the **African Union (AU)** and **COMESA**, noted that while polling was orderly in some areas, the overall environment was marred by an "uneven playing field." The European Union expressed regret over post-electoral violence, including reports of clashes in central Uganda that resulted in several deaths.

"We reject these results with all contempt. They are fake and don't reflect what happened at the polling stations." — Bobi Wine

What's Next for Uganda?

With Museveni now set to rule until 2031—marking **45 years in power**—the focus shifts to whether the opposition will pursue a legal challenge or call for mass civil disobedience. Additionally, internal speculation continues regarding his son, **General Muhoozi Kainerugaba**, who currently serves as the Chief of Defence Forces and is widely seen as a potential successor.

Four Promises by the Chief Minister of Tamil Nadu



On Thiruvalluvar Day (January 16, 2026), Tamil Nadu Chief Minister M.K. Stalin issued a significant pledge to the state, framing his governance through the lens of the *Kural*. - Intellectual Growth:** To launch and sustain initiatives that foster the “wisdom” and intellectual capacity of the younger generation (youth).
- Economic Empowerment:** To maintain the “energy” and constructive effort required for industrial development and the empowerment of women.

FACTS ABOUT BHARAT

This summary perfectly captures the dramatic transition of India from a mercantile hub to a colonial state. The history of the East India Company (EIC) is essentially the story of a private business that outgrew its own borders to become a sovereign power.

The Transformation: Merchant to Monarch

The EIC's journey is often divided into two distinct phases of influence:

1. The Mercantile Giant (1612–1757)

- Monopoly: Armed with a Royal Charter, the EIC held an exclusive right to British trade in the East.
- Economic Weight: At its peak, it handled nearly 50% of world trade.
- Global Impact: Indian textiles (calico, chintz, and muslin) became so popular in England that the British Parliament eventually passed "Calico Acts" to protect their own wool industry from Indian competition.

2. The Corporate State (1757–1858)

- The Turning Point: The Battle of Plassey (1757) transformed the Company. After defeating the Nawab of Bengal, they gained the *Diwani* rights (the right to collect land revenue), effectively becoming the tax collectors for one of the world's richest regions.
- Private Army: By the 1840s, the EIC commanded a private military of over 280,000 men—larger than the actual British

Army at the time. Most of these soldiers were Indian *sepoy*s.

Economic Shift: "The Drain of Wealth"

The transition from EIC rule to the British Raj saw a massive shift in India's global economic standing:

Period	India's Share of Global GDP	Key Export
1700	~24.4%	Finished Textiles, Spices
1858	~12.1%	Raw Cotton, Opium, Indigo
1947	~3-4%	Raw Materials

Note: Historians like Angus Maddison and Shashi Tharoor highlight that the EIC systematically de-industrialized India, turning it from the world's leading manufacturer of textiles into a captive market for finished goods from British mills.

The End of the Company (1858)

The Rebellion of 1857 (The Sepoy Mutiny) was the death knell for the EIC. The British Parliament realized that a private corporation could no longer be trusted to govern such a massive and volatile territory.

- The Act of 1858: Transferred all power, territories, and revenues to Queen Victoria.
- The British Raj: The Governor-General was given the new title of Viceroy, acting as the direct representative of the Crown.

- Liquidation: The East India Company was eventually dissolved in 1874, ending one of the most powerful and controversial corporate legacies in human history.
