Indian Railways to Double Originating Train Capacity in 48 Cities by 2030



In late December 2025, the Ministry Railways announced

transformative plan to double the originating train capacity in

major cities across India by 2030. This initiative is designed to tackle the rapid growth in and passenger demand reduce heavy congestion at existing urban hubs.

The plan will be implemented in phases over the next five years, with actions categorized as immediate, short-term, and long-term to ensure that passengers see benefits progressively rather than only at the 2030 deadline.

Key Strategic Pillars

The project moves beyond simple station upgrades to a holistic urban rail network strategy:

- Integrated Urban Planning: Rather than focusing only on a single "main" station, the plan integrates nearby satellite stations. For example, in Pune, capacity will be expanded not just at the main station but also at Hadapsar, Khadki, and Alandi to balance traffic.
- New Terminal Development: To decongest city centers, new terminals will developed in peri-urban areas. A prime example is the new Perambur terminal in



 - Financial: Banking transactions, credit card usage, and tax records.
 - Travel: Passport/Visa details. immigration logs, and railway/airline itineraries.

- Communication: Telecom KYC and Call Detail Records (CDR).
- Identity: Aadhaar, PAN, and now familylinked NPR data.



India to Lead the Prestigious Kimberley **Process Beginning January 2026**



In late December 2025, the Kimberley Process (KP) Plenary selected India to assume the prestigious Chairpersonship of the Kimberley Process starting January 1, 2026. This decision ends a year-long leadership impasse and places India, the world's largest diamond cutting and polishing hub, at the center of global diamond governance.

India is currently serving as the Vice Chair (effective December 25, 2025) and will succeed the United Arab Emirates (UAE) as the Chair in the new year.

India's Strategic Priorities for 2026

As a major player that polishes nearly 90% of the world's rough diamonds, India has outlined a tech-forward and ethical roadmap for its tenure:

- Digital Certification & Traceability: Moving away from paper-based systems to digital platforms (potentially utilizing blockchain) to reduce fraud and enable real-time verification of diamond origins.
- The "5th C" Conflict-Free: India aims to shift the industry standard beyond the traditional 4 Cs (Cut, Clarity, Color, Carat) to include a "5th C" for Conflict-Free status, boosting consumer trust.
- Strengthening Governance: Enhancing peermechanisms and rule-based compliance among the 60 participants (representing over 80 countries).
- Modernizing the Scope: India will lead delicate discussions on expanding the definition of "conflict diamonds" to include human broader rights abuses and

Key Facts: Kimberley Process (KP)

The KP is a unique tripartite initiative that brings together three distinct groups to ensure rough diamonds do not fund rebel movements:

Feature	Details
Objective	To prevent the trade of "conflict diamonds" (blood diamonds) used to finance wars against legitimate governments.
Reach	60 participants (including the EU as one) accounting for 99% of the global rough diamond trade.
India's	This is India's third time as Chair
History	(previously in 2008 and 2019).
Mechanism	The Kimberley Process Certification Scheme (KPCS) mandates that no rough diamond can be traded without a government-validated certificate.

Significance for India

The appointment is seen as a diplomatic victory and a boost for the Gem and Jewellery Export Promotion Council (GJEPC). It allows India to:

- 1. Lead during Geopolitical Shifts: Navigate complex trade issues, such as the G7 sanctions on Russian-mined diamonds.
- 2. Protect Industry Interests: As a massive importer of rough diamonds, India can

ensure that new regulations are practical and inclusive of manufacturing hubs.

"Viksit Bharat" 3. Reinforce Goals: Demonstrating leadership in ethical trade and global supply chain transparency.

Note: The KP currently covers less than 0.1% of the world's diamond production in terms of conflict, a massive drop from the 1990s when conflict diamonds made up nearly 15% of the trade.



In late December 2025, a groundbreaking scientific study published in *Current Science* added a new environmental chapter to the history of the Keezhadi settlement. While previous excavations focused on the age of the structures themselves (dating back to the 6th century BCE), this new research identifies exactly when and why parts of this "Vaigai Valley Civilization" were lost to nature.

The Scientific Breakthrough: OSL Dating

Researchers from the Physical Research Laboratory (PRL) and the Tamil Nadu Department of Archaeology used Optically Stimulated Luminescence (OSL) dating to analyze the sediment that buried the site.

- How it works: Unlike Radiocarbon dating, which dates organic matter (like charcoal or bone), OSL dates the last time mineral grains (like quartz) were exposed to sunlight.
- The Result: The study determined that a massive, high-energy flood event occurred approximately 1,155 years ago (around the late 9th or early 10th century CE), sealing the ancient urban layers under thick deposits of sand and silt.

Geological Evidence of the Flood

The stratigraphic layers at Keezhadi tell a story of a catastrophic hydrological event:

- The Layer Cake: Excavation pits (specifically KDI-1 and KDI-2) showed a clear sequence: coarser sand was found immediately beneath the brick structures, while fine silty clay was deposited above them.
- High-Energy Event: The coarse sand indicates a "high-energy" flood—a wall of water moving with enough force to carry heavy sediment. The silty clay above it suggests a period of "calmer deposition" as the floodwaters receded and stagnant water allowed fine particles to settle.
- River Migration: The Vaigai River currently flows several kilometers away from the Keezhadi mound. This study suggests that the 1,155-year-old flood might have been the catalyst for stream avulsion (the river abruptly changing its course), leading the population to eventually abandon or relocate the settlement.


Archaeological Signficance

Before this discovery, it was unclear if Keezhadi's decline was due to political shifts or environmental factors. This evidence aligns the site's history with known Late Holocene climate variability in South India.
