IGI Becomes India's First Water-Positive Airport



Delhi's Indira Gandhi International Airport (IGI) has earned the title of India's first water-positive airport among facilities handling more than 40 million passengers annually. This certification marks a milestone in sustainable airport operations and environmental stewardship. IGI achieved this goal by exp<mark>and</mark>ing rainwater harvesting, investing in storage systems and adopting advanced recycling mechanisms.

Key points of IGI Airport's large-scale water infrastructure includes:

- 625 rainwater harvesting structures
- Two underground reservoirs with a combined 9-million-litre capacity
- A 16.6 million-litre-per-day (MLD) zeroliquid-discharge sewage treatment plant







1998: Russia agrees to supply 'Krivak-class' multipurpose frigates to Indian Navy.



The Krivak class, Soviet designation Project 1135 Burevestnik (Stormy Petrel), is a series of frigates and patrol vessels built in the Soviet Union from the 1970s onwards, primarily for the Soviet Navy. Some later sub-branches, such as Nerei (Nereus), were designed for coastal patrol by the KGB Border Troops. Until 1977, ships of this class were considered large anti-submarine warfare vessels.
