> Government Introduces Assessment Model to Strengthen **Digital Loan Evaluation for MSMEs** 



The Government of India has launched a new Credit Assessment Model (CAM) to make the loan process faster and more transparent for Micro, Small and Medium Enterprises (MSMEs). The model aims to bring a digital-first approach to credit checks, reduce paperwork and help both old and new borrowers receive loans quickly. Along with this, the government is also supporting digital payments and expanding the PM SVANidhi scheme to help small businesses and street vendors grow.

Points:- The Credit Assessment Model is a technology-based system that uses verified digital data to check whether an MSME is eligible for a loan.

Sudan has given Russia the green light to set up its first-ever naval base in Africa. The deal was finalized after talks in Moscow between Sudanese Foreign Minister Ali Youssef Ahmed al-Sharif and Russian Foreign Minister Sergei Lavrov.


> PNB Appoints Harmanpreet Kaur as Its First-Ever Female Brand **Ambassador** 





1768 - First edition of Encyclopædia Britannica



Britannica' The 'Encyclopædia considered one of the lasting achievements of the Scottish Enlightenment. The 'Britannica', first issued in 1768, originated in Edinburgh. It was published by Colin Macfarquhar (1744/5-1793), a printer and engraver Andrew Bell (1725/6-1809).

### 1917 - Finland declares independence from Russia

Finland declared its independence from the Russian Empire on December, 1917, shortly after the Bolshevik Revolution. The United States recognized Finland on May 7, 1919, in a letter written by

Secretary of State Robert Lansing to Finnish Foreign Minister Rudolf Holsti.



The earliest settlement in Finland occurred after the last ice age, around 9000 B.C. During the Stone Age, various cultures emerged, distinguished different styles of pottery. The Bronze Age and Iron Age were marked by contacts with other cultures in Fennoscandia and the Baltic region.

1946 - Government established in India.



The Interim Government of India was formed in 1946, and it is this government


