India's Finance Minister Inaugurates 18th Plenary Meeting of the Global Forum on Tax Information Exchange



India has opened the 18th Plenary Meeting of the Global Forum Transparency and Exchange Information for Tax Purposes in New Delhi. The event, being held on December 2025, focuses on the theme Transparency: Delivering a Shared Through Vision International With Cooperation." 172 jurisdictions, the Global Forum is the world's biggest platform working to prevent tax evasion and strengthen financial transparency.

Key Points: -

The finance minister said that transparency in taxation is not just a technical requirement but a value that supports development.

She explained that when money leaves the tax system unlawfully, countries lose resources needed for growth.

Bharat Taxi Begins Trials in Delhi and Gujarat







■ HISTORICAL AND TECHNICAL EVENTS OF 5TH DECEMBER 2025

1856 - First officially solemnised 'Hindu widow' marriage in the country.



The Hindu Widow Remarriage Act 1856, also called Act XV, 1856, passed on 16 July 1856, legalised the remarriage of widows in all jurisdictions of India under the rule of the East India Company. The law was enacted on 26 July 1856.

It was drafted by Lord Dalhousie and passed by Lord Canning before the Indian Rebellion of 1857. It was the first major social reform law after the abolition of Sati in 1829 by Lord William Bentinck.






1972 - The most beautiful picture of Earth taken from space

1966 - NASA launched ATS-1 satellite


