

How to change Active Voice into Passive Voice?

1. Make the object of the active sentence-Subject of the passive sentence.

Example: I write a letter. (Active Voice)

Object of Active sentence is 'a letter'. It becomes subject of the passive sentence. (A letter....)

2. Make the subject of the active sentence-Agent of the passive sentence. The agent will be in objective form. Use 'by' before it. 'By' is used when the subject of active sentence is important to mention.

Subject of active sentence is . Its objective form is 'me". So... by me

3. Always use third form of the verb (past participle) in passive structures. The past participle (V-III) will be preceded by 'to be' form of verb, as per the tense of the sentence.

Please take care that the 'to be' form of verb is governed by the new subject (subject of the passive sentence).

Examples:

(a) I write a letter. (Active) A letter is written by me. (Passive) (b) She is helping the students. (Active) The students are being helped by her. (Passive)

Here in sentence (b) plural verb- are is used as per the new subject - students.

5. Change of Subject of Active sentence into Object of Passive is done as per following table:

- 6. Only transitive verbs (those that take objects) can be transformed into passive constructions. Furthermore, active sentences containing certain verbs cannot be transformed into passive structures. To have is the most important of these verbs. We can say "He has a new cycle", but we cannot say "A new cycle is had by him". Here is a brief list of such verbs: resemble, look like, equal, agree with, mean, contain, hold, comprise, lack, suit, fit, become. These verbs are intransitive in nature.
- 7. Sentences in Present Perfect Continuous', 'Past Perfect Continuous', 'Future Perfect Continuous' and 'Future Continuous' can't be transformed into Passive.

The change of verbs (tense wise) take place as per following table:

Tense	Verb (Active)	Verb (Passive)	To be form + V - I
1. Simple Present	write writes	am/is/are	written
2. Simple Past	wrote	was/were	written
3. Simple Future	shall/will - write	shall/will be	written
4. Present Continuous	is/am/are – writing	is/am/are	being written
5. Past Continuous	was/were – writing	was/were - being	written
6. Present Perfect	has/have - written	has/have – been	written
7. Past Perfect	had written	had been	written
8. Future Perfect	will/shall have written	will/shall have been written	

Miscellaneous Sentences

(i) Passive of verbs showing, state of mind or feelings: Some verbs do not express any action but simply state of mind or feelings. We should not use 'by' in passive structures of such sentences, instead an appropriate preposition is used.

Active

(a) I know her. She is known to me. (Preposition-to)

(b) He annoyed her. She was annoyed with him. (Preposition-with)

(c) Her behaviour annoyed him He was annoyed at her behaviour. (Preposition-'at')

(d) The news surprised all. All were surprised at the news. (Preposition.-'at')

(e) The result amazed me. I was amazed at the result. (Preposition-'at)

(ii) Passive of verbs with Appropriate Prepositions: Some verbs take preposition before an object. The preposition remains intact even in passive construction.

(a) He laughed at me. I was laughed at by him.

(b) The police is enquiring into the matter The matter is being enquired into by the police.

(c) Sita smiled at Ram. Ram was smiled at by Sita.

(d) He looks after his parents. His parents are looked after by him.


(e) Rahim mocked at our class teacher. Our class teacher was mocked at by Rahim.

Such commonly used verbs are; look at, look after, laugh at, smile at, deride at, mock at etc.




